**AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 860
RELATING TO ESTABLISHING A SCHEDULE OF FEES FOR THE ISSUANCE OF
WARRANTS AND SERVICES BY THE AUDITOR-CONTROLLER OF THE
COUNTY OF RIVERSIDE**

The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

Section 1. The "Charge per Manual Change" and "Charge per Batch Parcel Change" fees listed under the heading "Services" in Section 1 of Ordinance No. 860 are amended, respectively, as follows:

Charge per Manual Special Assessment Correction	\$29.00, each
Charge per Batch Special Assessment Corrections	\$87.00 per batch AND \$0.08 per parcel

Section 2. Any of the fees listed in Section 1 of Ordinance No. 860 not specifically amended herein shall remain unchanged.

Section 3. This Ordinance shall take effect 30 days after its adoption.




