

SUBJECT: The Waste Recycling Park Phase 1 Development Project at the Lamb Canyon Sanitary Landfill - Notice of Completion

- RECOMMENDED MOTION:** That the Board of Supervisors:
1. Accept the Construction of the Waste Recycling Park Phase 1 Development Project at the Lamb Canyon Sanitary Landfill by Road Builders, Inc., and authorize the Chairman to execute a Notice of Completion.
 2. Direct the County Clerk to file the executed Notice of Completion.
 3. Authorize reduction of the project retention funds from 10 percent to 5 percent.

BACKGROUND: On August 29, 2006 the Board awarded Road Builders, Inc., the contract to construct the Waste Recycling Park Phase 1 Development Project at the Lamb Canyon Sanitary Landfill. On February 15, 2007, construction was satisfactorily completed on time and within budget. The Department has accepted the work; therefore, recommends filing a Notice of Completion. The original contract amount was \$1,689,727.00. The final total cost of the project is \$1,671,209.70. In addition, as provided by State law, the contractor has requested, and the Department agrees that it is appropriate, to reduce the retention funds from 10 percent to 5 percent of the total final cost of the project.
