**BACKGROUND:**

On June 26, 2006, (Agenda #3.55), the Board approved the Agreement #06C-1628 with CSD for \$258,400 to fund the 2006 DOE-WAP program.

Amendment #1 to Agreement #06C-1628 would extend the end of the term of the agreement from January 31, 2007 to March 31, 2007, to allow for final expenditure for previously approved activities. All other terms and conditions under this agreement remain unchanged.

Therefore, the Director of DPSS-CAP Riverside requests that the Board approve and authorize the Chairman of the Board to sign this Amendment #1 to the Agreement #06C-1628 covering the term April 1, 2006 through March 31, 2007.
