SUBJECT: Amend Riverside County Ordinance 671 to establish a fee to recover costs for issuing a graffiti sales license and for conducting an annual inspection to monitor graffiti implement sales and locations to insure compliance with Riverside County Ordinance 733.

RECOMMENDED MOTION: That the Board of Supervisors approve the amendment to Riverside County Ordinance 671.

BACKGROUND: Ordinance 733 requires that by March 31st of each year, the Department of Building and Safety will establish a fee to recover the cost of administering and monitoring graffiti sales throughout the County of Riverside. The current business license program currently captures most of the information to register retail outlets that sell graffiti implements but does not address the specific graffiti sales approval process. The cost to process this additional information and issue the initial graffiti sales license is estimated at \$45 with an annual renewal fee of \$30. In addition, an annual inspection is required to monitor locations to insure they are complying with the ordinance. Based on experience in conducting similar type inspections by the Department of Building and Safety staff, it is anticipated that each inspection will require 1/2 hour of inspection time billed at the Building Inspector II fully burdened rate of \$131/hr. As such, the total cost to the retail establishment for the graffiti sales license will be \$45 for the first year and \$95.50 for renewal (\$30 for the renewal certificate and \$65.50 for the 1/2 hour inspection). All of the fees collected with this program are intended to recover costs and to be expended only on service provided.
