SUBJECT: Change the Name of Chase School Road to Cook Street, in the Thousand Palms area, Fourth Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2007-026, Changing the Name of Chase School Road to Cook Street.

BACKGROUND: This change is at the request of a property owner who feels that the street name change from Chase School Road to Cook Street will aid the public and the emergency response system in the area to utilize Interstate 10 directional signage when seeking direction north of Interstate 10. The adjacent property owners have been notified of the proposed name change and the Transportation Department has not received any letters in opposition. Seven (7) letters were sent and four (4) responded in favor of the name change. Three (3) property owners have not responded.

The Historic Preservation Office was contacted and they have no objection to the street name change.

8 **WHEREAS**, pursuant to Section 970.5 of the Streets and Highways Code, a
9 public hearing after due notice has been held upon a resolution of intention to change
10 the name of **Chase School Road** lying between Varner Road and the north line of Lot
11 "A" of Tract 23672, as shown on file in Book 206 of Maps, at pages 29 through 32,
12 inclusive, Records of Riverside County, California, in Sections 27 and 28, T. 4 S., R. 6
13 E., S.B.M., as shown on attached Exhibit "A", Fourth Supervisorial District, to **Cook**
14 **Street**, and all persons having had an opportunity to be heard; now, therefore;
