
**RECOMMENDED MOTION:** That the Board execute and file the attached "Notice of Completion"

**BACKGROUND:** By Minute Order 3.29 of November 23, 2004, the Board entered into an agreement with All American Asphalt of Corona, CA for the reconstruction of Corydon Street, from Grand Avenue to Mission Trail, widening of Union Street, and associated improvements in Lake Elsinore area of Riverside County. The authorized amount of the contract was \$684,684.00. The total amended contract amount (including quantity adjustments) is \$736,086.06, which is 7.5% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on November 3, 2005. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order A2-0277.


