RECOMMENDED MOTION: APPROVE the Cooperative Agreement between the County of Riverside (County), the Flood Control District (Flood), the Redevelopment Agency for the County of Riverside (RDA), the Jurupa Area Recreation and Park District (JARPD), RTE. 60, LLC (RTE. 60), SunCal Emerald Meadows LLC (SunCal) and the owners of certain properties located within the boundaries of Parcel Map No. 32971; and **AUTHORIZE** the Chairman to execute the Agreement documents on behalf of the County.

Departmental Concurrence

BACKGROUND: This Agreement is necessary for the proposed development of the "Emerald Meadows Ranch" project (Parcel Map No. 32971) located in the community of Rubidoux. It establishes the terms and conditions by which SunCal will construct the Emerald Meadows Channel and related drainage facilities and provides for District and County inspection of the proposed drainage improvements. Upon completion of construction, the District will assume ownership, operation and maintenance of the channel and major storm drains. The County will assume ownership, operation and maintenance of the associated road culverts, catch basins, laterals and connector pipes located within its rights of way.
