1. Authorize the Chairman of the Board to sign the attached Amendment # 1 between Riverside County Department of Public Social Services (DPSS) and MFI Recovery Center to increase funding to \$225,000 for the period of August 1, 2006 through June 30, 2007.
2. Authorize the Purchasing Agent to sign any ministerial amendments with MFI Recovery Center, not to exceed the maximum amount of the Agreement (\$225,000); and
3. Authorize the Director of DPSS to administer the Agreement with MFI Recovery Center.

**SUBJECT: SUBSTANCE ABUSE TREATMENT SERVICES AGREEMENT AMENDMENT #1 FOR
2006/2007 FISCAL YEAR – MFI RECOVERY CENTER**

BACKGROUND:

On August 29, 2006, (Agenda 3.62) the Board approved an agreement on behalf of DPSS with MFI Recovery Center to provide substance abuse treatment services not to exceed \$150,000.

Objectives of the Substance Abuse Treatment Services program are to provide residential, outpatient, and detoxification drug treatment services to DPSS child protective services clients in Riverside County. These services provided by MFI are essential for clients who require intensive substance abuse treatment as quickly as possible to assist with reunification efforts.

An increase in referrals by DPSS to MFI Recovery Center will deplete current funding for this program by April 2007. These services are crucial to reducing reunification time for parents involved in substance abuse. In order to ensure that services continue to be available to our clients, we are forwarding the attached amendment to your Board for approval.

FINANCIAL DATA:

The annual cost to the County for these services will be \$33,750.
