
**SUBJECT:** Landscaping and Lighting Maintenance District No. 89-1-Consolidated, Annexation of Zone 94.



**BACKGROUND:** Adoption of Resolution No. 2007-165 appoints the Director of the Transportation Department as the Engineer to prepare a Report regarding the proposed annexation of Zone 94 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C").

Resolution No. 2007-166 declares the Board's intention of ordering the annexation of Zone 94 to L&LMD No. 89-1-C. Annexation of Zone 94 to L&LMD No. 89-1-C will fund providing electricity for streetlights and the maintenance and servicing of fossil filters within public right-of-way located southwesterly of A Street and northeasterly of Nuevo Rd in the Mead Valley area and includes 1 commercial parcel.

The proposed budget for fiscal year 2007/08 for Zone 94 is \$5,700.00 that will result in an assessment for fiscal year 2007/08 within Zone 94 of \$744.12 per acre. The annual assessment will be adjusted annually by the greater of 2% or the cumulative percentage increase in the CPI-U, if any, as it stands as of March of each year over the base index for March of 2007.

Consistent with the Board's direction regarding compliance with Article XIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on June 12, 2007 to receive testimony for and against the proposed assessment. Each property owner within the proposed Zone 94 will receive a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2007-166, and an information sheet.

Ballots must be returned prior to the conclusion of the public hearing. If, at the time designated for the tabulation of the ballots, the ballots submitted in favor of the annexation and levy of the assessment exceed the ballots submitted in opposition of said annexation and levy, Zone 94 will be annexed to L&LMD No. 89-1-C.

There is only one individual/entity which owns all of the property within the proposed boundaries of Zone 94 and said property owner has executed a "Waiver and Consent Regarding Date of Assessment Ballot Election" allowing for the election and public hearing to be held on June 12, 2007.

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE INITIATING PROCEEDINGS FOR THE ANNEXATION OF ZONE 94 TO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED OF THE COUNTY OF RIVERSIDE PURSUANT TO THE LANDSCAPING AND LIGHTING ACT OF 1972 AND ORDERING PREPARATION OF ENGINEER'S REPORT REGARDING SAID ANNEXATION**

**WHEREAS**, the Board of Supervisors (hereinafter the "Board of Supervisors") of the County of Riverside (hereinafter the "County") has been advised by the Transportation Department (hereinafter "Department") of the County that said Department has received an application from the owner (the "Applicant") of all the property within the unincorporated area of the County (hereinafter "Zone 94"), as shown and described in Exhibit "A", which is attached hereto and made a part hereof, to be annexed to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (hereinafter "L&LMD No. 89-1-C") of the County of Riverside, State of California, and the Board of Supervisors has determined that it is necessary and desirable to initiate proceedings for the annexation of Zone 94 to L&LMD No. 89-1-C pursuant to the Landscaping and Lighting Act of 1972, Part 2 (commencing with Section 22500) of Division 15 of the Streets and Highways Code (hereinafter, respectively, the "Act" and the "Street and Highways Code"); and

**WHEREAS**, such proceedings shall comply with the requirements of Article XIID of the California Constitution and Section 4000 of the Elections Code requiring voter approval of the proposed assessment to be levied by L&LMD No. 89-1-C for Zone 94; and

**WHEREAS**, the Applicant has executed a "Waiver and Consent Regarding Date of Assessment Ballot Election" allowing for the election to be held on June 12, 2007; and

**WHEREAS**, the Director of the Department, or his designee, is a licensed and registered civil engineer, has expertise with respect to the annexation of territory to landscaping and lighting maintenance districts and the levying of assessments for said purposes and, therefore, is able to serve

1 as the engineer (hereinafter the "Engineer") for the County with regard to the annexation of Zone 94 to  
2 L&LMD No. 89-1-C.

3 **NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by the  
4 Board of Supervisors of the County of Riverside assembled in regular session on April 17, 2007 as  
5 follows:

6 **Section 1. Recitals.** The Board of Supervisors hereby finds and determines that all  
7 the above recitals are true and correct.

8 **Section 2. Annexation.** The Board of Supervisors proposes to annex Zone 94 to  
9 L&LMD No. 89-1-C and to initiate and conduct proceedings therefore pursuant to the Act for the  
10 purpose of levying an annual assessment on all parcels within Zone 94 to pay the costs of the  
11 following services:

- 12 (a) The maintenance and servicing of fossil filters within the public right-of-way  
13 including the removal of petroleum hydrocarbons and other pollutants from  
14 water runoff; and  
15 (b) Providing electricity to all streetlights within the public right-of-way including  
16 incidental costs and expenses.


17 **Section 3. Boundaries and Designation.** The boundaries of Zone 94 that are  
18 proposed to be annexed to L&LMD No. 89-1-C shall include all of the property as shown and  
19 described in Exhibit "A".

20 **Section 4. Report.** The Director of the Department of the County, or his designee,  
21 is hereby designated Engineer and is ordered to prepare and file a report with the Clerk of the Board  
22 of Supervisors in accordance with Sections 22608 and 22585 et. seq. of the Streets and Highways  
23 Code and Section 4 of Article XIID of the California Constitution regarding said annexation and the  
24 levy.

25 **Section 5. Effective Date.** This Resolution shall take effect from and after its date  
26 of adoption.

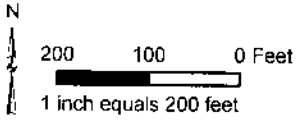
**DESCRIPTION OF BOUNDARIES**

**ZONE 94**

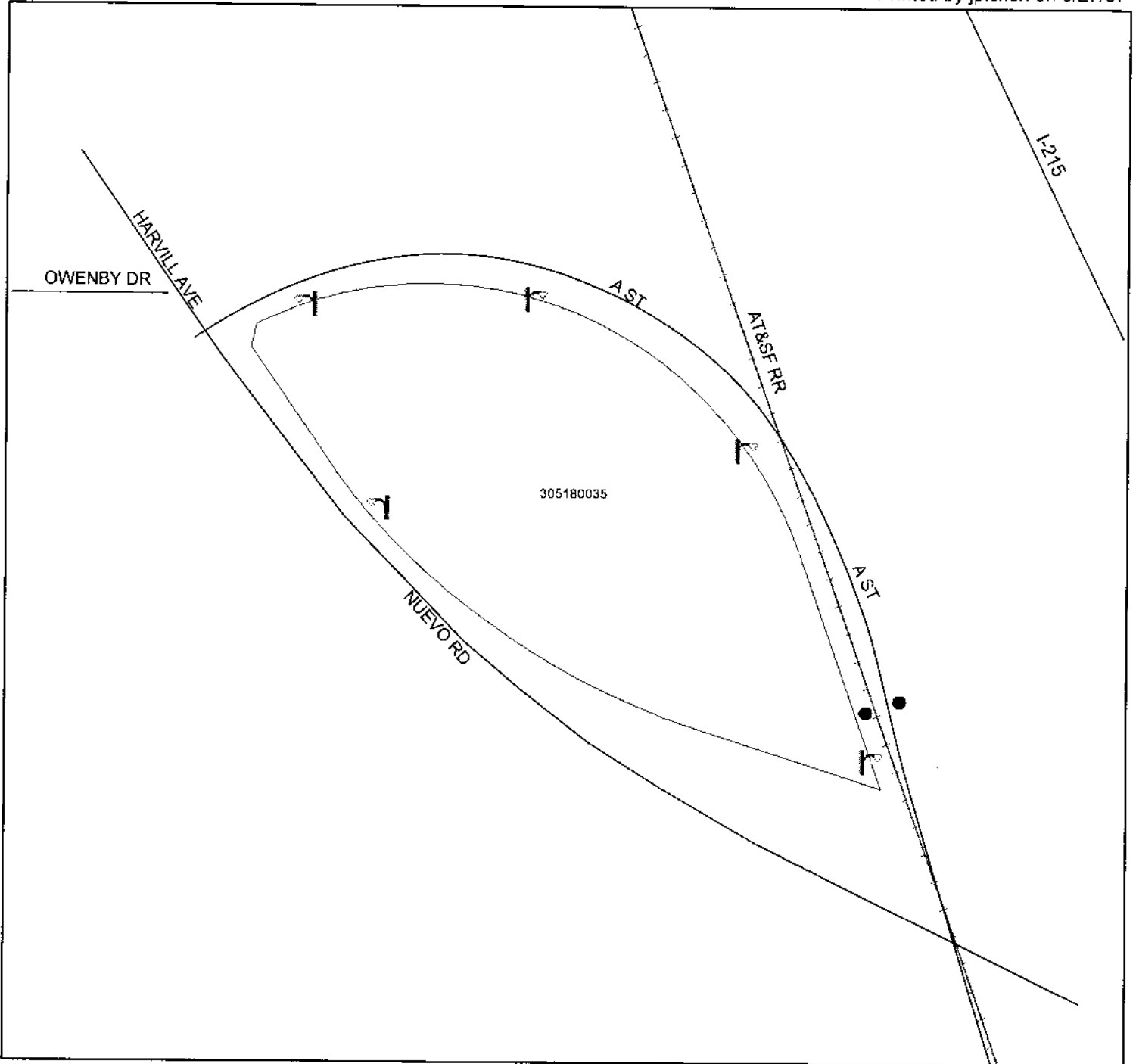
PORTION OF SECTION 19, T.4S., R.3W

3 RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE DECLARING  
4 ITS INTENT TO ORDER THE ANNEXATION OF ZONE 94 TO LANDSCAPING AND LIGHTING  
5 MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED OF THE COUNTY OF RIVERSIDE  
6 PURSUANT TO THE LANDSCAPING AND LIGHTING ACT OF 1972 FOR THE MAINTENANCE  
7 AND SERVICING OF STREETLIGHTS AND FOSSIL FILTERS; ADOPTING THE PRELIMINARY  
8 ENGINEER'S REPORT; GIVING NOTICE OF AND SETTING THE TIME AND PLACE OF THE  
9 PUBLIC HEARING ON THE ANNEXATION OF ZONE 94; ORDERING AN ASSESSMENT  
10 PROCEEDING; ORDERING A MAILED BALLOT ELECTION; AND DIRECTING NOTICE OF THE  
11 PUBLIC HEARING AND THE ASSESSMENT BALLOT TO BE MAILED PURSUANT TO ARTICLE  
12 XIIID OF THE CALIFORNIA CONSTITUTION AND SECTION 4000 OF THE ELECTIONS CODE

13 **WHEREAS**, the Board of Supervisors (hereinafter the "Board of Supervisors") of the County of  
14 Riverside (hereinafter the "County") has adopted Resolution No. 2007-165 on April 17, 2007 initiating  
15 proceedings for the annexation of Zone 94 (hereinafter "Zone 94"), as described and shown in  
16 Exhibit "A", which is attached hereto and incorporated herein, to Landscaping and Lighting  
17 Maintenance District No.89-1-Consolidated of the County of Riverside, State of California, (hereinafter  
18 "L&LMD No. 89-1-C") pursuant to the Landscaping and Lighting Act of 1972 (hereinafter the "Act"),  
19 which is Part 2 (commencing with Section 22500) of Division 15 of the Streets and Highways Code  
20 (hereinafter the "Street and Highways Code"), and ordering the preparation of a report (hereinafter the  
21 "Report") regarding the proposed annexation of Zone 94 and the assessments to be levied within  
22 Zone 94 each fiscal year beginning fiscal year 2007/08 for the providing electricity for streetlights and  
23 the maintenance and servicing of fossil filters within the public right-of-way within said Zone; and

24 **WHEREAS**, such proceedings shall comply with the requirements of Article XIIID of the  
25 California Constitution (hereinafter "Article XIIID:."), the Act, and Section 4000 of the Elections Code  
26 requiring voter approval of the proposed assessment to be levied by L&LMD No. 89-1-C for Zone 94;  
and

**WHEREAS**, the Board of Supervisors by Resolution No. 2007-165 directed the Director of the  
Transportation Department, or his designee (hereinafter the "Engineer"), to prepare and file the Report

1 with the Clerk of the Board of Supervisors in accordance with Sections 22608 and 22585 et. seq. of the  
2 Street and Highways Code and Section 4 of Article XIID; and

3 **WHEREAS**, said Engineer has filed the Report with the Clerk of the Board of Supervisors and  
4 the Report has been presented to and considered by the Board of Supervisors; and

5 **WHEREAS**, the Applicant has executed a "Waiver and Consent Regarding Date of Assessment  
6 Ballot Election" allowing for the election to be held on June 12, 2007; and

7 **WHEREAS**, it is necessary that the Board of Supervisors adopt a resolution of intention  
8 pursuant to Section 22624 of the Streets and Highways Code, which fixes and gives notice, pursuant to  
9 Section 22626 of the Streets and Highways Code, of the time and place of a public hearing on said  
10 Report, the annexation of Zone 94, and the assessments to be levied on parcels within Zone 94  
11 beginning in fiscal year 2007/08;

12 **NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by the  
13 Board of Supervisors in regular session assembled on April 17, 2007 as follows:

14 **Section 1. Findings.** The Board of Supervisors, after reviewing the Report, finds that:

- 15 (a) The foregoing recitals are true and correct;
- 16 (b) The Report contains all matters required by Sections 22565 through 22574 of the  
17 Streets and Highways Code and Section 4 of Article XIID and may, therefore, be  
18 approved by the Board of Supervisors;
- 19 (c) The annual assessment for fiscal year 2007/08 on all parcels within Zone 94 proposed to  
20 be annexed to L&LMD No. 89-1-C will be \$744.12 per acre.

21 **Section 2. Intent.** The Board of Supervisors hereby declares its intention to order the  
22 annexation of Zone 94, as described and shown in Exhibit "A", to L&LMD No. 89-1-C, and to levy and  
23 collect an annual assessment on all assessable lots and parcels of property within Zone 94  
24 commencing with the fiscal year 2007/08 as set forth in the Report. The Report expressly states that  
25 there are no parcels or lots within Zone 94 that are owned by a federal, state or other local  
26 governmental agency that will benefit from the services to be financed by the annual assessments. The

1 annual assessments will be collected at the same time and in the same manner as property taxes are  
2 collected, and all laws providing for the collection and enforcement of property taxes shall apply to the  
3 collection and enforcement of said assessments.

4 **Section 3. Boundaries.** All the property within boundaries of Zone 94 is proposed to be  
5 annexed into L&LMD No. 89-1-C and shall include that property in the unincorporated area of the  
6 County as described and shown in Exhibit "A".

7 **Section 4. Description of Services to be Provided.** Providing electricity for streetlights  
8 and the maintenance and servicing of fossil filters authorized for Zone 94 of L&LMD No. 89-1-C are:

- 9 (a) The maintenance and servicing of fossil filters within the public right-of-way including the  
10 removal of petroleum hydrocarbons and other pollutants from water runoff; and  
11 (b) Providing electricity to all streetlights within the public right-of-way including incidental  
12 costs and expenses.

13 **Section 5. Amount to be Levied.** The assessment to be levied upon each parcel that  
14 benefits from the annexation of Zone 94 of L&LMD No. 89-1-C will be \$744.12 per acre for fiscal year  
15 2007/08. As stated in the Report, the total budget for Zone 94 for the fiscal year 2007/08 is \$5,700.00;  
16 there is 1 parcel that is to be assessed that aggregates to 7.66 acres. The annual assessment will be  
17 increased by the greater of two percent (2.0%) or the cumulative percentage increase, if any, in the  
18 Consumer Price Index for all Urban Consumers ("CPI-U") for the Los Angeles-Riverside-Orange  
19 County California Standard Metropolitan Statistical area ("Index") published by the Bureau of Labor  
20 Statistics of the United States Department of Labor. The annual CPI-U adjustment will be based on the  
21 cumulative increase, if any, in the Index as it stands on March of each year over the base Index for  
22 March of 2007. Any increase larger than the greater of 2.0% or the CPI-U annual adjustment requires a  
23 majority approval of all the property owners within Zone 94. The Board of Supervisors will levy the  
24 assessment in each subsequent fiscal year until the Board of Supervisors undertakes proceedings for  
25 the dissolution of Zone 94 of L&LMD No. 89-1-C. The annual assessment will fund the services  
26

1 described in Section 4 of this Resolution. For further particulars, reference is to be made to the Report  
2 on file in the Office of the Clerk of the Board of Supervisors.

3 **Section 6. The Property to be Annexed.** The property to be annexed into L&LMD No.  
4 89-1-C is Zone 94. The boundaries of Zone 94 are located within the unincorporated area of the County  
5 and are described and shown in the Report and Exhibit "A".

6 **Section 7. Report.** The Report, which is on file with the Clerk of the Board of Supervisors  
7 and which has been presented to the Board of Supervisors, is hereby approved. Reference is made to  
8 the Report for a full and detailed description of the services, the boundaries of Zone 94, and the annual  
9 assessment to be levied upon assessable lots and parcels within Zone 94 proposed to be annexed to  
10 L&LMD No. 89-1-C.

11 **Section 8. Public Hearing.** The question of whether Zone 94 shall be annexed into L&LMD  
12 No. 89-1-C and an annual assessment levied beginning with fiscal year 2007/08 shall be considered at  
13 a public hearing (hereinafter the "Public Hearing") to be held on June 12, 2007, at 9:30 a.m. at the  
14 meeting room of the Board of Supervisors of the County at 4080 Lemon Street, 1<sup>st</sup> Floor, Riverside,  
15 California.

16 **Section 9. Majority Protest.** Each owner of record of property within Zone 94 is to receive  
17 by mail an assessment ballot that shall conform to the requirements of Section 4 of Article XIID and  
18 Section 4000 of the California Elections Code. The assessment ballots are to be returned prior to the  
19 Public Hearing. L&LMD No. 89-1-C shall not impose assessments on property within the boundaries of  
20 Zone 94 if there is a majority protest with regard to the annexation of Zone 94. A majority protest exists  
21 if, upon the conclusion of the Public Hearing, the tabulation of the assessment ballots submitted in  
22 opposition to the annexation and assessment of Zone 94 exceeds the assessment ballots in favor of  
23 the annexation and assessment of Zone 94.

24 **Section 10. Information.** Any property owner desiring additional information regarding  
25 Zone 94 of L&LMD No. 89-1-C, the Report, or the proposed assessment is to contact Ms. Judy A.  
26 Watterlond, Technical Engineering Unit Supervisor, Transportation Department of the County of

1 Riverside, 4080 Lemon Street, 8th Floor, Riverside, California, 92501 or by telephone at  
2 (951) 955-6829.

3       **Section 11. Notice of the Public Hearing.** Notice of Public Hearing with regard to the  
4 annexation of Zone 94 to L&LMD No. 89-1-C shall be given consistent with Section 22626 of the  
5 Streets and Highways Code and Section 4 of Article XIID. The Clerk of the Board of Supervisors shall  
6 give notice of the Public Hearing by causing a certified copy of this Resolution to be published once in  
7 *The Press Enterprise* at least ten (10) days prior to the date of the Public Hearing that is June 12, 2007.  
8 Publication of this Resolution is to be effected by the Clerk of the Board of Supervisors. Notice shall  
9 also be given by mailing first-class, postage prepaid, those notices, as prepared by County Counsel,  
10 assessment ballot and information sheets as required by Section 4 of Article XIID and Section 4000 of  
11 the California Elections Code to all owners of record of property within Zone 94 as shown on the last  
12 equalized assessment roll of the County. Mailing is to be made by the Engineer and deposited with the  
13 U. S. Post Office at least forty-five (45) days prior to the Public Hearing on June 12, 2007.

14       **Section 12. Effective Date.** This Resolution shall take effect from and after its date of  
15 adoption.

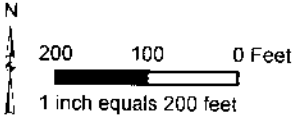

PORTION OF SECTION 19, T.4S., R.3W

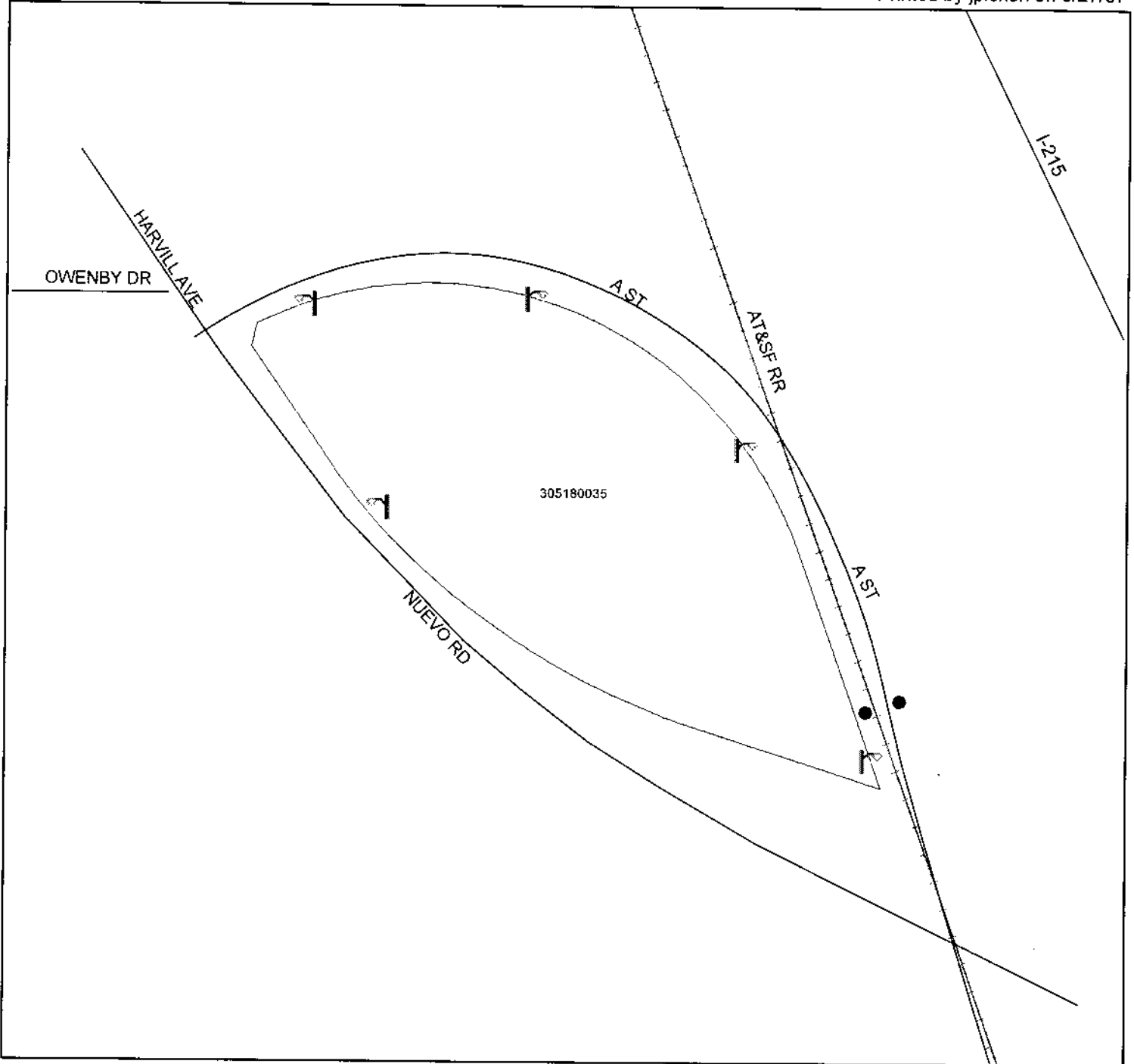
PARCEL MAP NO. 30328 - 1 PARCEL
