SUBJECT: FY07 Emergency Management Performance Grant Program

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve Resolution # 2007-228 that identifies the local Emergency Management Performance Grant (EMPG) Governing Body; and
- 2) Authorize Riverside County Fire – O.E.S to apply to the Governor's Office of Emergency Services for \$ 274,850 in formula based EMPG funding on behalf of the Riverside County Operational Area.

BACKGROUND: Although the Governing Body for EMPG is already in place, it is a requirement to provide a new Governing Body Resolution each year with the application. The purpose of EMPG funding is to support comprehensive emergency management at the state, tribal and local levels and to encourage the improvement of mitigation, preparedness, response, and recovery capabilities for all hazards. Eligible grant recipients are California's 58 Operational Areas. Riverside County Fire Department Office of Emergency Services (O.E.S) applies on behalf of the Riverside County Operational Area. Each recipient is eligible to receive an allocation that consists of a \$50,000 base award with remaining funds distributed using per capita figures. There is a 50/50 cash or in-kind match which will be derived from local cities and jurisdictions. (Continued)

Riverside County Operational Area's access to the formula-based award is through an application that represents the consensus of the Riverside County Operational Area Planning Committee (OAPC), the advisory council that consists of Riverside County agencies and jurisdictions. During the grant performance period, OAPC members will submit eligible projects for approval of funding. Each agency that receives funding will be responsible for providing the 50% cash or in-kind match requirement.

It is anticipated that O.E.S may request approval for approximately \$25,000 in EMPG funding to complete activities that meet EMPG goals and objectives. If approved, OES would be required to meet the 50/50 match by providing \$25,000 in matching funds derived from currently budgeted staff salaries and travel costs.
