**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—
SAINT VINCENT DE PAUL MANAGEMENT**

RECOMMENDED MOTION: That the Board of Supervisors ratify and:

1. Authorize the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program Grant for \$525,000 for the period of December 1, 2006 through November 30, 2007;
2. Authorize the Chairman of the Board to sign the attached Contract, HU 3367-00, between DPSS and Saint Vincent De Paul;
3. Authorize the Purchasing Agent to sign any ministerial amendments with Saint Vincent De Paul, not to exceed the maximum amount of the Grant Agreement (\$525,000); and
4. Authorize the Director of DPSS to administer the agreement with Saint Vincent De Paul.

BACKGROUND:

On June 7, 2005, your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for Martha's Village and Kitchen Supportive Housing Project operated through a contract between Saint Vincent De Paul and DPSS to provide transitional housing and supportive services to families and individuals living in Indio.

The previous grant ended on November 30, 2006. HUD executed the attached renewal grant agreement on January 18, 2007, which we are forwarding to your Board for approval. Saint Vincent De Paul's annual goal is to serve 86 families and 61 individuals annually. Saint Vincent De Paul's capacity has been at 67% and 95% respectively and plans to continue its goals over the current grant cycle.

FINANCIAL DATA: No County General Funds are required.
