3. Authorize the Executive Director of DPSS-CAP Riverside to sign assurances, exhibits, and reports made under this agreement; and
4. Authorize the Executive Director of DPSS-CAP Riverside to administer the program.

BACKGROUND:

For many years, SCG has provided funding for the Riverside County DAP weatherization program to install weatherization measures, including appliance repair and replacement, in homes of eligible low-income residents of Riverside County and conduct energy education workshops. Agreement #5660008507 with SCG establishes funding for program year 2007 for the term, January 1, 2007 through January 24, 2008.

Therefore, the Director of DPSS-CAP Riverside requests that the Board approve and authorize the Chairman of the Board to sign Agreement #5660008507 with SCG in the amount of \$71,530 covering the term January 1, 2007 through January 24, 2008.

FINANCIAL IMPACT: No County General Funds will be required. \$23,843 will be expended in FY 06/07. The balance will be included in FY 07/08 through the normal budgeting process.
