SUBJECT: Professional Services Agreement between the County of Riverside and Vernon Brockman, D.D.S.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Professional Services Agreement with Vernon Brockman, D.D.S., effective March 1, 2007; and
- 2) Authorize the Chairperson to execute three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed agreements to Riverside County Regional Medical Center (RCMRC) administration for distribution.

BACKGROUND: RCRMRC was awarded grant funding from the RCCFC, First 5 Riverside program to provide dental screening and oral health education to children age 5 and under living throughout the County of Riverside. Vernon Brockman, D.D.S. has agreed to provide dental screening, including cleaning and fluoride treatment along with education services related to children's oral health. Dr. Brockman has also agreed to assist with screening programs and health fairs to identify children that qualify for First 5 Program services throughout the County of Riverside.
