SUBJECT: Professional Services Agreement between the County of Riverside and Manuela Sosa, D.D.S.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Professional Services Agreement with Manuela Sosa, D.D.S., effective March 1, 2007; and
- 2) Authorize the Chairperson to execute three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed agreements to Riverside County Regional Medical Center (RCMRC) administration for distribution.

BACKGROUND: RCRMC was awarded grant funding from the RCCFC, First 5 Riverside program to provide dental screening and oral health education to children age 5 and under. Manuela Sosa, D.D.S. has agreed to provide dental screening, including cleaning and fluoride treatment in addition to oral health education services to patients and their families. Dr. Sosa has also agreed to assist with screening programs and health fairs throughout the County of Riverside to identify children, living in Riverside County, that qualify for First 5 Dental Program services.
