SUBJECT: Professional Medical Services Agreement between the County of Riverside and Loma Linda University Physicians Medical Group, Inc.

RECOMMENDED MOTION:

- 1) Ratify the Professional Medical Services Agreement, effective April 1, 2007;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendment to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: Effective April 1, 2007 three professional service agreements, providing Rheumatology Services to RCRMC were combined into a single professional medical services agreement with Loma Linda University Physicians Medical Group, Inc. All of the physicians, Drs. Colburn, Finley and Krick, will continue providing rheumatology outpatient clinic and inpatient hospital consultative services under this new agreement. In addition to combining the individual professional service agreements, the medical group will provide an additional half-day Rheumatology clinic, per week, to the hospital's outpatient clinic.

This increase to Rheumatology services will decrease the current backlog of physician referrals requesting Rheumatology specialty care services.

All of the required services, including teaching, oversight and administrative responsibilities have been incorporated into the agreement that clearly outlines the duties, obligations and responsibilities of the Contractor.
