SUBJECT: FY 2007/2008 Standard Agreement AP-0708-21 between California Department of Aging and County of Riverside for Title III/VII and Community Based Service Programs

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and Authorize Chair to execute Standard Agreement AP-0708-21 for FY 2007-2008 with the California Department of Aging.

BACKGROUND: Funds provided under this Agreement support the provision of services, programs and other activities for senior citizens Countywide in accordance with Title III & Title VII of the Older Americans Act and the Older Californians Act. The services include Supportive Services and Senior Centers (IIIB), Congregate and Home Delivered Nutrition (IIIC & NSIP), Preventive Health and Medication Management (IIID), National Family Caregiver Support (IIIE), Long Term Care Ombudsman Services (VII-a), Elder Abuse Prevention (VII-b) and Community Based Service Programs of Brown Bag, Alzheimer's Day Care Resource Centers, Linkages, and Respite Purchase of Service, as developed in our countywide strategic plan for aging services. The term of this agreement is from July 1, 2007 through June 30, 2008.



BACKGROUND: (Continued)

The agreement amount of \$6,974,588 includes an increase of \$258,482 over the current year. We are requesting additional county match of \$21,968, bringing the total general fund support to \$779,010. If approved, funding for this contract will be included in the FY 07/08 budget.

This Agreement reflects the current contract from California Department of Aging and is subject to some modifications based on the State final legislative process.
