SUBJECT: Amending Ordinance No. 527.2, "Flies & Fly Abatement Committee".

RECOMMENDED MOTION:

1. That the Board introduce and set for Public Hearing the adoption of Ordinance No. 527.3 amending Ordinance No. 527.2 which regulates the control of flies;
2. That the Board authorize the Clerk to place an advertisement for the Public Hearing in the appropriate local publications;
3. That, upon the close of the Public Hearing, the Board adopts Ordinance 527.3.

BACKGROUND: This amendment to Ordinance No. 527 will add language referencing Riverside County Ordinance No. 725, which establishes procedures and penalties for violations of Riverside County Ordinances and provides for recovery of costs reasonably related to enforcement. Specifically, the changes to this ordinance can be found in Section 10, the second paragraph – which allows additional remedies and penalties related to the Administrative citation process outlined in Ordinance No. 725.
