**BACKGROUND:**

DPSS submitted and was approved for CDBG funding by the city of Moreno Valley in the amount of \$5,000. This money will be used to help defray the costs of the emergency cold weather shelter operated out of the Hulen Place shelter. This much needed service during last year's inclement weather season helped many of the city's homeless.

During the 2004-05 fiscal year, 9,139 bed nights were provided to the homeless people in the city of Riverside. During the 2005-06 fiscal year, 11,576 bed nights were provided. This increase is due to the longer period of time the shelter was opened, and the expansion of the shelter to a second site to handle the overflow.

Therefore, the Director requests the Board's approval of the recommended motions.

This is the first year the city of Moreno Valley provided CDBG funding to DPSS. Previously, the city of Palm Desert provided CDBG funding. The Board previously approved CDBG funding agreements with the city of Palm Desert on 10/29/02 (#3.24), 11/30/04 (#3.18) and 10/18/05 (#3.42).

**FINANCIAL IMPACT:**

Funds have been provided by the City of Moreno Valley. There is no cost to the County.
