SUBJECT: AGREEMENT WITH PREVENT CHILD ABUSE RIVERSIDE COUNTY (PCARC)

RECOMMENDED MOTION: That the Board of Supervisors approve and:

1. Authorize the Chairman of the Board to execute the attached Agreement #CH0524-00 between Riverside County Department of Public Social Services (DPSS) and Prevent Child Abuse Riverside County (PCARC). The Agreement is not to exceed \$439,920 and will cover the term from July 1, 2007 through June 30, 2008 with two renewal options.
2. Re-designate Prevent Child Abuse Riverside County as the lead child abuse council for Riverside County;
3. Authorize the Purchasing Agent to sign ministerial amendments and exercise renewal options not to exceed \$439,920 annually; and
4. Authorize the Director of DPSS to administer the program.

SUBJECT: AGREEMENT WITH PREVENT CHILD ABUSE RIVERSIDE COUNTY (PCARC)

BACKGROUND:

In accordance with State laws governing the funding and administration of child abuse, neglect, prevention, and intervention programs, your Board designated DPSS as the public administrator of the Child Abuse Prevention, Intervention and Treatment Program as well as the Community Based Family Resource and Support Program (Agenda item 3.31, August 14, 2001). Additionally, on August 24, 2004, (Agenda item #3.51) your Board approved and re-designated Prevent Child Abuse Riverside County (PCARC) as the lead child abuse council for Riverside County through June 30, 2007.

At this time, DPSS is requesting that the Board re-designate PCARC as the lead child abuse council and approve the attached contract for fiscal year 07/08 with two renewal option years.

FINANCIAL DATA:

The funding for PCARC is provided from the Children's Trust Fund. Pursuant to State regulations, PCARC is required to provide a cash or in-kind match of 33 1/3% in addition to the funding allocated under this agreement. There is no additional cost to the county.
