BACKGROUND: By Minute Order 3.44 of October 17, 2006, the Board entered into an agreement with Palomar Grading & Paving, Inc. of Escondido, CA for the repair of a portion of Scott Road, from Antelope Road to Ashford Lane, Menifee area of Riverside County. The authorized amount of the contract was \$946,525.75. The total amended contract amount (including Change Orders and quantity adjustments) is \$1,012,237.66, which is 6.9% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on March 28, 2007. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4505120112
