SUBJECT: Workforce Investment Act (WIA) Title 1B Community College Education Assistance Center (CCEAC) Funding Recommendation.

RECOMMENDED MOTION: That the Riverside County Board of Supervisors:

1. Approve the recommendation funding a maximum of \$185,000 to Riverside Community College District (RCCD) to operate the CCEAC for Program Year (PY) 2007-2008; and
2. Authorize the Workforce Development Administrator to negotiate and execute an agreement.

BACKGROUND: In 2006, the Riverside County Workforce Development Board identified the need for an enhanced workforce system linkage to education, especially to the community college system, and awarded funding to Riverside Community College District to operate a Community College Education Assistance Center as a pilot project. The center, which opened on September 1, 2006, targets individuals who are apprehensive about attending college by having center staff provide information on a variety of educational resources offered through community colleges, assist individuals in navigating through the system and provide career exploration and job preparation workshops. A Request for Proposal was released on February 13, 2007 to solicit applicants for the delivery of these services. RCCD submitted the only proposal. At their April 18, 2007 meeting the Workforce Development Board's Executive Committee approved the recommended funding.
