**SUBJECT:** Workforce Investment Act (WIA) Youth Opportunity Center Funding Recommendation

**RECOMMENDED MOTION:** That the Board of Supervisors approve the Youth Opportunity Center Funding recommendations for Program Year (PY) 2007-2008 and authorize the Workforce Development Administrator to negotiate and execute agreements within 10% of the recommended funding amount.

**BACKGROUND:** The Youth Opportunity Centers (YOC) of Riverside County provide "one stop" access for both in-school and out-of-school youth who need help in achieving long-term goals in the areas of education, occupational skills, life skills and employment. The purpose of these centers is to create a comprehensive youth development system that coordinates services and leverages resources by bringing together an array of public and community-based organizations, as well as employers, to serve at-risk youth in the community. At their May 16, 2007 meeting the Workforce Development Board's Executive Committee approved funding for six YOC's in the following geographic areas: Indio, Perris, Hemet/San Jacinto, Lake Elsinore, Riverside and Jurupa. These funds will ensure continued services at the existing YOC's in the communities with the greatest need and the least amount of resources.
