**SUBJECT:** Renewal Agreement SD2215-00 FY 2007/2008 with The Foundation for California State University, San Bernardino

**BACKGROUND:**

On November 21, 2006, (Agenda #3.16), your Honorable Board approved the agreement between the Department of Public Social Services (DPSS) and the Foundation for California State University, San Bernardino to provide induction training to Children Services Social Services Workers.

The Foundation for California State University, San Bernardino has been under contract with the State of California since 1998 to provide initial and advanced training to the staff of the five Southern California Public Child Welfare Services agencies. California State University, San Bernardino is one of several educational institutions that are available to perform this service in Southern California.

The original agreement with the Foundation was for two training series of fifteen (15) classes. Each series accommodated up to thirty-one (31) Social Service Workers. On April 10, 2007, (Agenda #3.13), your Honorable Board approved Amendment#1 to increase the training series to five to accommodate hiring new Social Workers by DPSS. Since training is necessary, this renewal agreement will extend this service for an additional fiscal year. The rates for the training series were established and approved by the state and have been consistent since the Contract Agreement was executed in 2006.

DPSS negotiated the agreement with the Foundation without competition in accordance with California Department of Social Services (CDSS) manual section 23-650, paragraph 1.14, which states that contracts may be negotiated without formal advertising "for any service to be rendered by any federal, state or local governmental agency, public university, public college or other public educational institution."

Therefore, the Director of DPSS requests that the Board approve and sign this renewal Agreement between DPSS and The Foundation for California State University, San Bernardino covering the term July 1, 2007 through June 30, 2008.
