**SUBJECT:** Fleet Services Storage Tank Removal and Installation - Notice of Completion

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Accept the Fleet Services Storage Tank Removal and Installation project, constructed by Fleming Environmental, as complete and authorize the Clerk of the Board to file the Notice of Completion; and
2. Authorize the release of \$ 44,380.72 in retained funds to the contractor in accordance with the contract terms.

**BACKGROUND:** On February 1, 2006, the Board of Supervisors approved a contract with Fleming Environmental, Inc. for the removal of underground storage tanks and the installation of new above ground storage tanks at the Fleet Vehicle Maintenance Facility located in Moreno Valley. The project was inspected and found to comply with all contract documents. This Board action will release the balance of the contract retention funds of \$44,380.72 to Fleming Environmental.
