**SUBJECT: RENEWAL OF SUBSTANCE ABUSE TREATMENT SERVICES AGREEMENT FOR 2007/2008
FISCAL YEAR - MFI RECOVERY CENTER**

RECOMMENDED MOTION: That the Board of Supervisors approve and:

1. Authorize the Chairman of the Board to sign the attached Agreement between Riverside County Department of Public Social Services (DPSS) and MFI Recovery Center to provide substance abuse treatment services for the period of July 1, 2007 through June 30, 2008 in an amount not to exceed \$225,000.
2. Authorize the Purchasing Agent to sign any ministerial amendments and renewal options with MFI Recovery Center, for an amount not to exceed the contract maximum of \$225,000; and
3. Authorize the Director of DPSS to administer the Agreement with MFI Recovery Center.

**SUBJECT: RENEWAL OF SUBSTANCE ABUSE TREATMENT SERVICES AGREEMENT FOR
2007/2008 FISCAL YEAR – MFI RECOVERY CENTER**

BACKGROUND:

Objectives of the Substance Abuse Treatment Services program are to provide residential, outpatient, and detoxification drug treatment services to DPSS child protective services clients in Riverside County. These services provided by MFI are essential for clients who require intensive substance abuse treatment as quickly as possible to assist with reunification efforts.

On April 10, 2006, the Department of Public Social Services (DPSS) issued a formal Request for Proposal (RFP) to solicit proposals for Substance Abuse Treatment Services. The RFP was sent to 17 bidders and advertised on the internet. MFI Recovery Center was found to be the most responsive and responsible bidder and was recommended to receive the contract award.

On August 29, 2006 (Agenda #3.62), the Board approved agreement # CP 3123-00 between DPSS and MFI for \$150,000 for the period of August 1, 2006 through June 30, 2007. An amendment to the contract was requested and approved on April 17, 2007 (Agenda # 3.26) to increase funding to MFI from \$150,000 to \$225,000 for fiscal year 2006-07. This increase in funding was necessary to prevent a projected shortfall due to an increase in referrals by DPSS to MFI Recovery Center.

This program has been noted by social workers, clients and the Department to be a highly valued and utilized resource. A renewal is being sought in order to prevent disruption of services that contribute to the safety and stability of the families we serve.
