**SUBJECT:** Professional Medical Services Agreement between the County of Riverside and Nephrology Associates Medical Group, Inc.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Professional Medical Services Agreement with Nephrology Associates Medical Group, Inc. effective May 1, 2007; and
- 2) Authorize the Chairperson to sign three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed Agreement to Riverside County Regional Medical Center (RCRMC) for distribution.

**BACKGROUND:** Nephrology Professional medical services have been provided by Joseph Lee, M.D., John Robertson, M.D. and Chao Huang Sun, M.D. with individual professional medical service agreements since January 1993. This agreement with Nephrology Associates Medical Group, Inc. replaces the individual professional medical service agreements and will allow all of the group's physicians to provide nephrology services at the Hospitals outpatient clinics. This new agreement increases the number of nephrology clinics from two (2) half-day

**BACKGROUND (Continued):**

clinics to three (3) half day nephrology clinics per month increasing patient access to Nephrology Professional services.

All nephrology professional services, including teaching, administrative and oversight duties and responsibilities have been incorporated into the agreement that clearly outlines the duties, obligations and responsibilities of the Contractor.

This Agreement has been approved as to form by County Counsel.

**FINANCIAL IMPACT:**

Maximum annual compensation payable under this Agreement is sixty-eight thousand (\$68,000) dollars. Total fiscal year cost is based upon the two (2) month period of May 1, 2007 thru June 30, 2007.
