**SUBJECT:** State Standard Agreement #07-08-01

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve the State Standard Agreement #07-08-01 with the California Department of Corrections and Rehabilitation, for wards of the State assigned to the Heman G. Stark Youth Correctional Facility effective July 1, 2007; and
- 2) Adopt Resolution No. #2007-240 approving the execution of State Standard Agreement #07-08-01 dated July 1, 2007; and
- 3) Authorize the Chairperson to execute four (4) copies of the Agreement; and
- 4) Direct the Clerk of the Board to return all four (4) copies of the signed originals to RCRMC Administration and one (1) signed resolution # 2007-240. Upon final approval by the State, a fully executed agreement will be returned to the Clerk of the Board.

**BACKGROUND:** The California Department of Corrections and Rehabilitation has agreed to a new agreement with RCRMC to providing inpatient/outpatient, medical/surgical services for the wards assigned to the Heman G. Stark Youth Correctional Facility. This new agreement increases the amounts paid by the State for the services provided by the Hospital. This Agreement has been approved as to form by Riverside County Counsel.
