**SUBJECT:** Approval of the First Amendment to the Agreement with Animal Action League to Provide Free Spay/Neuter Surgeries to the Animals of Riverside County

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve the First Amendment to the Agreement with Animal Action League and the County of Riverside for the performance period from July 1, 2007 through June 30, 2008 in the amount of \$48,999; and,
- 2) Authorize the Chairperson to execute four (4) copies of the Amendment.

**BACKGROUND:** The Riverside County Department of Animal Services (DAS) has taken a proactive approach to reduce pet overpopulation within Riverside County. DAS has utilized various avenues to accomplish this through different spay/neuter programs, such as the Pet Over-Population Coalition (POPCO) Voucher Program, the DAS Spay/Neuter Mobile, the Riverside City/County Low-Cost Spay/Neuter Clinic and partners throughout the County who provide free or low-cost surgeries.

**BACKGROUND:**

Aside from the DAS mobile spay/neuter clinic, Animal Action League (AAL) is the only spay/neuter provider servicing Riverside and San Bernardino counties through a mobile spay/neuter clinic. AAL travels to remote, low income areas of the County to provide free or low-cost spay/neuter surgeries to areas with large unaltered animal populations and few, if any, veterinarians.

This amendment provides for AAL to continue their spay/neuter efforts through DAS' low-cost POPCO spay/neuter program in the amount of \$24,999 and the addition of \$24,000 to provide free spay/neuter services for Riverside County residents, for a total contract amount of \$48,999 for FY07/08.

**Financial Information:**

Sufficient funds have been budgeted in Fiscal Year 2007/08 and no additional County funds are required.
