**SUBJECT:** Ratify Sole Source Procurement of mental health treatment for anorexia from Loma Linda University Behavioral Medicine Center

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Ratify the Sole Source Procurement of medically necessary mental health treatment of life-threatening eating disorder (anorexia) provided by Loma Linda University Behavioral Medicine Center to a Riverside County Medi-Cal consumer.
2. Authorize the Purchasing Agent to approve payment in the amount of \$31,160 to Loma Linda University Behavioral Medicine Center for said treatment.

**BACKGROUND:** Loma Linda University Behavioral Medicine Center offers a highly specialized treatment program for the eating disorder anorexia. This facility provides a comprehensive program of multiple levels of care including partial hospitalization, intensive outpatient and an ongoing support group specifically for the treatment of anorexia. This program has a proven track record of providing successful treatment to consumers at risk of death from the complications of anorexia.
