5 ACCEPTING A PORTION OF ORANGE STREET AND BOYD AVENUE, IN THE
6 CORONA AREA, FOR PUBLIC USE.

10 **WHEREAS**, the hereinafter described portions of Orange Street and Boyd Avenue
11 were offered for dedication for road and public utility purposes by the Tract Map hereinafter-
12 referred to, which offers of dedication have not been previously accepted for public use by
13 the County of Riverside, now, therefore;

14
15 **BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of Supervisors of
16 the County of Riverside, State of California, in regular session assembled on July 3 ,
17 2007, that this Board accepts the offers of dedication and recognizes that said roads are
18 public roads open for use by the general public;

19
20 **BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED** that this acceptance
21 is for the purpose of vesting title in the County of Riverside on behalf of the public for public
22 roads and utility uses, and is not an acceptance of the roads into the County Maintained
23 Road System pursuant to Section 941 of the Streets and Highways Code and that said roads
24 will not become part of the County Maintained Road System unless subsequently accepted
25 into said Maintained Road System by a resolution adopted by this Board;

3 Said roads are in the County of Riverside, State of California, and is described as follows:

5 **ORANGE STREET** (See Exhibit "A")

6 That portion of Orange Street (50.00 feet wide) shown as lot "L", on the "Map of
7 Overlook Addition #3" to Corona recorded in Book 14 pages 47 through 49, inclusive of
8 Maps, Official Records of Riverside County, California, lying southerly of the southerly right of
9 way line of Bedford Canyon Road as relinquished to the County of Riverside per Instrument
10 No. 98305 Recorded October 4, 1966.

11
12 **Boyd Avenue** (See Exhibit "A")

13 That portion of Boyd Avenue (25.00 feet wide) shown as lot "Z", on the "Map of
14 Overlook Addition #3 to Corona" recorded in Book 14 pages 47 through 49, inclusive of
15 Maps, Official Records of Riverside County, lying easterly of the southerly prolongation of the
16 westerly right of way line of Corona Street (Lot "I") and lying westerly of the southerly
17 prolongation of the easterly right of way line of Orange Street (Lot "L").

19 **BE IT FURTHER RESOLVED** that the Clerk of the Board shall cause a certified copy of this
20 resolution to be recorded in the Office of the County Recorder of Riverside County, California.

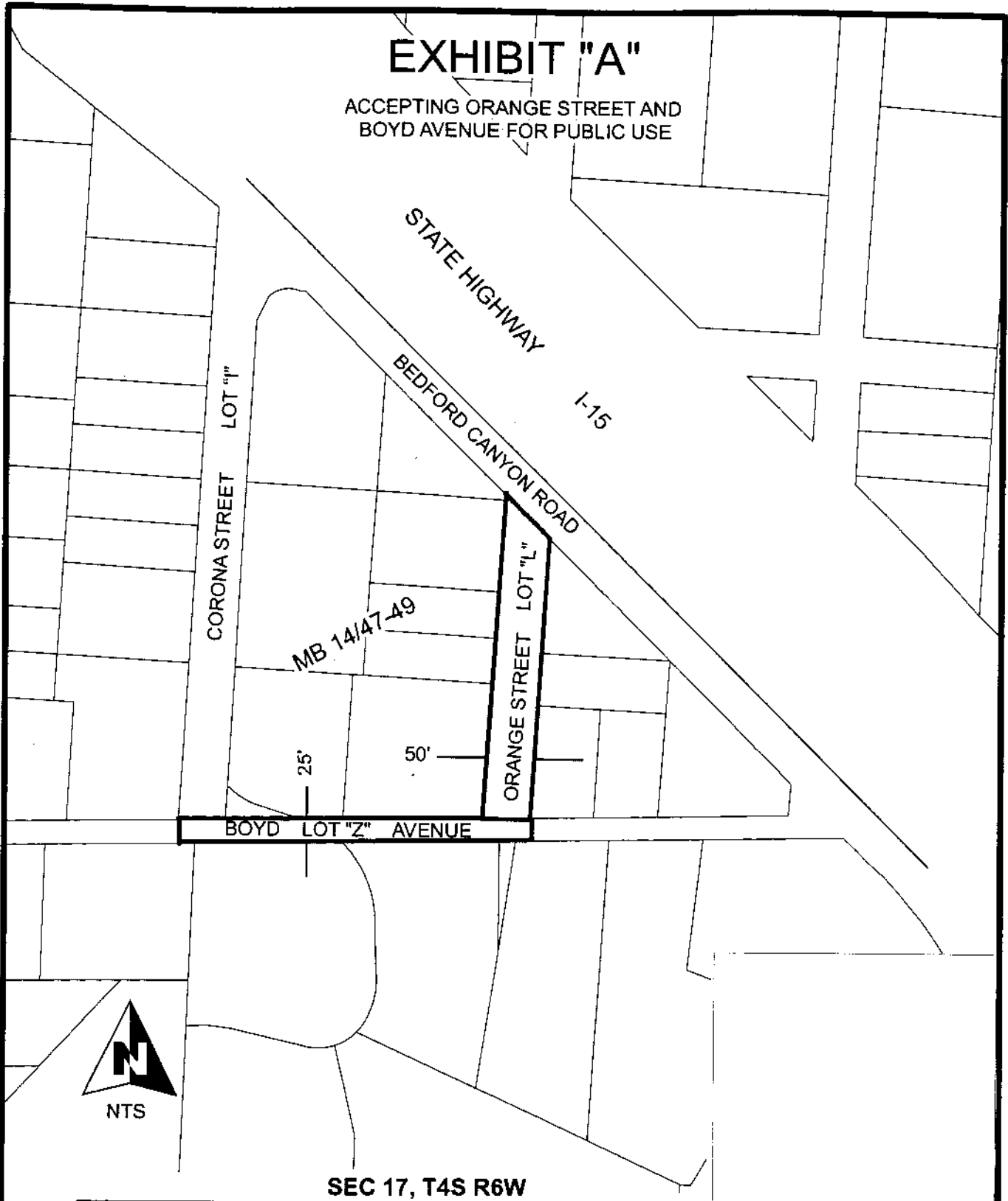

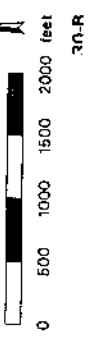
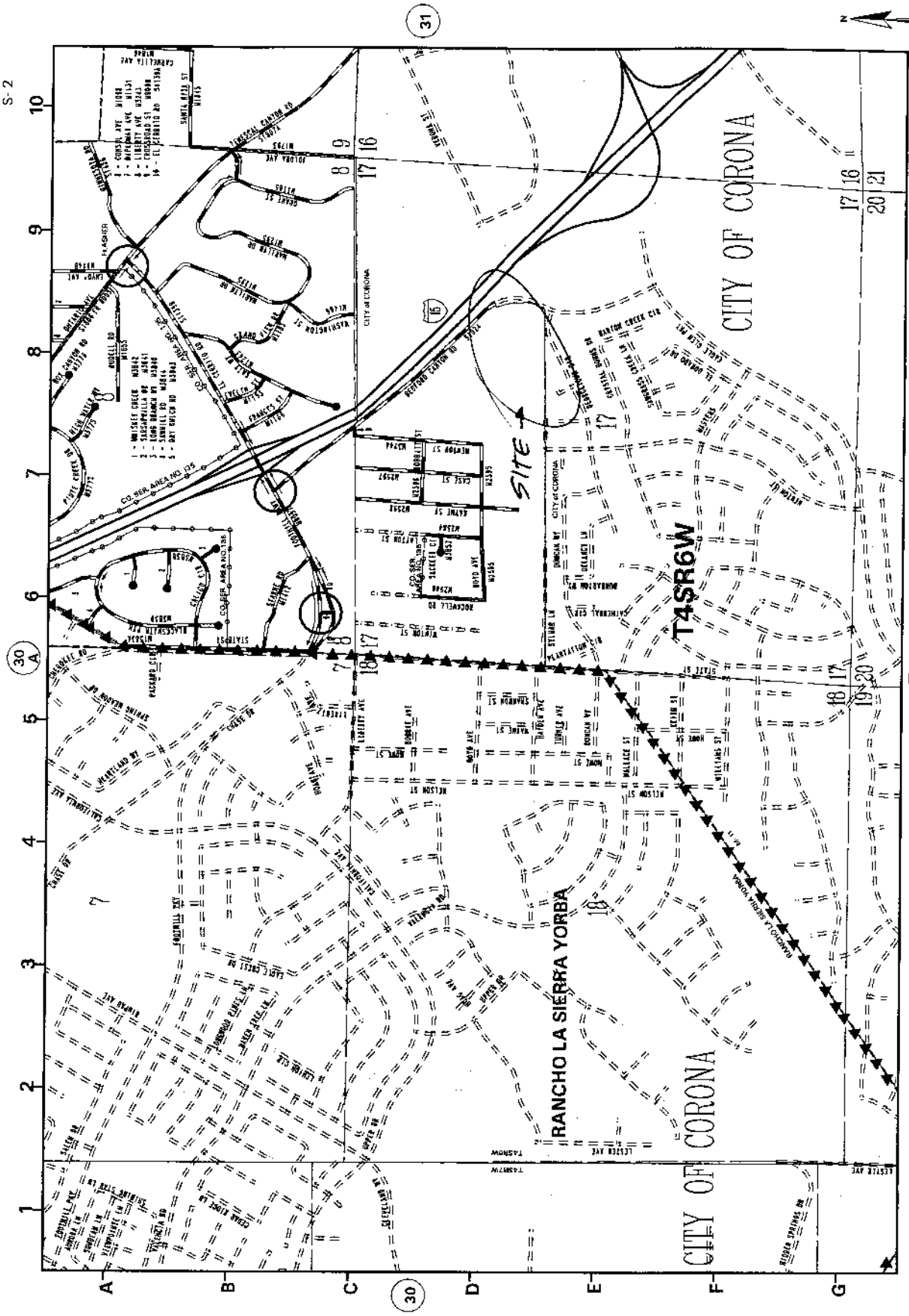
