**BACKGROUND:** By Minute Order 3.46 of January 23, 2007, the Board entered into an agreement with Grand Pacific Contractors of Mira Loma, CA for the Reconstruction of Eight Specific Segments of De Luz Road, Southwest of Rancho California Road, Temecula area of Riverside County. The authorized amount of the contract was \$1,679,097.00. The total amended contract amount (including quantity adjustments) is \$1,512,305.54, which is 9.9% less than the originally authorized amount.

This work was completed in conformance with the plans and specifications on May 18, 2007. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4505120110.
