**SUBJECT:** Cooperative Agreement between the County and City of Blythe for Roadway Improvements on 10<sup>th</sup> Avenue from De Frain Boulevard to Ehlers Boulevard and from State Highway 95 (SH 95) to approximately 1.2 miles east of SH 95.

**RECOMMENDED MOTION:** That the Board approve the Cooperative Agreement between the County and City of Blythe for Roadway Improvements on the subject project, and authorize the Board Chairman to execute the same.

**BACKGROUND:** The County plans to reconstruct pavement on 10<sup>th</sup> Avenue from De Frain Boulevard to Ehlers Boulevard and from State Highway 95 (SH 95) to approximately 1.2 miles east of SH 95 in the City of Blythe and unincorporated areas of Riverside County. The pavement reconstruction will consist of pulverizing the existing pavement and placing a 0.33-foot thick layer of asphalt as a top course.

A portion of this work falls within the City of Blythe jurisdiction. The County and City mutually determined the great need for the improvements and both agreed that the County will take the lead in constructing the improvements, and the City will reimburse the County for the portion that falls within the City's jurisdiction. The total improvements are estimated at \$340,000. By this agreement, the City of Blythe will reimburse funds to the County up to \$141,760 for the City's share of the improvements.
