SUBJECT: Timeshare Internet Tax Sale, TC-178, scheduled for October 15th through October 22nd, 2007.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the intended timeshare Internet tax sale, TC-178
- 2) Approve and adopt the provisions of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c) and Section 4703(a),
- 3) Adopt Resolution 2007-320 approving the sale of tax-defaulted property, prepared and approved by County Counsel, and
- 4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Tax Collector following Board approval.

The above action will authorize the minimum bid on timeshares to be offered for sale, via the Internet, scheduled for October 15th through October 22nd, 2007.

BACKGROUND: Properties for which taxes are not paid are sold to collect back taxes. After the property has been tax-defaulted for a period of five or more years from the original tax-default year, it becomes subject to the Tax Collector's "Notice of Power To Sell Tax-Defaulted Property", which is then recorded. If the property is not subsequently redeemed by the payment of all amounts due, it is offered for sale by the Tax Collector. (Continued)

BACKGROUND: (Continued)
SUMMARY OF THE TIMESHARE INTERNET SALE:

On October 15, 9:00 AM through October 19, 2007 9:00 AM, the Tax Collector will offer a total of one hundred seventy-seven (177) timeshare intervals at the Desert Breezes Resort located in Palm Desert.

- Seventy-two (72) 1 & 2 bedroom prime season timeshare intervals will be offered for the first time for a minimum bid of full redemption, plus the 540.00 cost of sale per interval.
- Thirty-one (31) 2 bedroom high season timeshare intervals will be offered for the first time for a minimum bid of full redemption, plus the 540.00 cost of sale per interval.
- Seventy-four (74) 1 bedroom high season and Mini/Studio prime & high season timeshare intervals will be offered for the first time for a minimum bid of full redemption, plus the 540.00 cost of sale per interval.

On October 19, 10:00 AM through October 22, 2007 10:00 AM, the timeshare intervals that were offered for the first time on the October 15, 2007 and did not receive a bid, can now be reoffered at a reduced minimum bid.

Assuming 1 & 2 bedroom prime season timeshare intervals do not sell on October 15, 2007, seventy-two (72) intervals will be reoffered on October 19, 2007 for the minimum bid of \$1,000.00 each, which includes the cost of sale.

- Thirty-five (35) 1 & 2 bedroom prime season timeshare intervals represent a loss of taxes ranging from 1% to 39%.
- Thirty-seven (37) 1 & 2 bedroom prime season timeshare intervals represent no loss of taxes.

Assuming 2 bedrooms high season timeshare intervals do not sell on October 15, 2007, thirty-one (31) intervals will be reoffered on October 19, 2007 for the minimum bid of \$750.00 each, which includes cost of sale.

- Twenty-nine (29) 2 bedrooms high season timeshare intervals represent a loss of taxes ranging from 25% to 78%.
- Two (2) 2 bedrooms high season timeshare intervals represent no loss of taxes.

Assuming 1 bedroom high season and Mini's/Studio's prime & high season timeshare intervals do not sell on October 15, 2007, seventy-four (74) intervals will be reoffered on October 19, 2007 for the minimum bid of \$540.00 each, which is the cost of sale.

- Seventy-four (74) 1 bedroom high season and Mini's/Studio's prime & high season timeshare intervals represent a 100% loss of taxes.

For this sale, if all timeshare intervals reoffered sell for the minimum bid, the maximum tax loss would be \$39,752.08. Taking into account the Teeter formula, which shares this loss with other taxing entities, the maximum loss to the Tax Loss Reserve Fund would be \$ 29,197.91. A sufficient balance exists in the Tax Loss Reserve Fund to allow for this loss and still transfer to the General Fund the surplus amount included in this year's budget. Therefore there is no direct budgetary impact.

8 WHEREAS, the Tax Collector of Riverside County intends to sell at public auction, over
9 the Internet, tax-defaulted property subject to the power of sale, on October 15, 2007 through October 22,
10 2007, and requests that the Board of Supervisors of the County of Riverside, State of California approve
11 the intended sale, and any postponement of the sale that may be necessary; the Tax Sale List TC 178 Sale
12 File 4335 is attached herewith as Exhibit "A" and sets forth the property declared tax-defaulted with the
13 year of the tax-default and the assessment number; the notice of the proposed sale will be sent to the State
14 Controller in accordance with Section 3700.5 of the California Revenue and Taxation Code; and

15 WHEREAS, the Tax Collector in his discretion has determined that the property specified
16 in Exhibit "A" attached hereto and incorporated by reference, should be offered for sale on October 15,
17 2007 through October 22, 2007, at a minimum bid in accordance with California Revenue and Taxation
18 Code Section 3698.5, and

19 WHEREAS, three groups of timeshare intervals totaling one hundred and seventy seven
20 (177) timeshare intervals, or less, in the Desert Breezes Resort in Palm Desert will be offered at the tax
21 sale for the first time at the full redemption amount plus cost of sale, if these timeshare intervals do not
22 sell for the full redemption amount plus cost, they will be reoffered at the conclusion of the tax sale a
23 reduced bid; and

24 WHEREAS, the Tax Collector has determined that due to unique circumstances that the
25 timeshare intervals that are being offered for the first time may not sell, therefore these intervals should be
26 reoffered at the same sale at a reduced bid; and

27 WHEREAS, it is in the best interests of the State of California, the County of Riverside,
28 and cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said

1 properties; now, therefore,

2 BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the
3 County of Riverside, State of California, in regular session assembled on July 17, 2007, that the proposed
4 internet sale of tax-defaulted property subject to the power of sale and any continuation of the sale is
5 hereby approved and the Tax Collector of the County of Riverside is directed to offer the property
6 described in Exhibit "A" attached hereto and incorporated by reference, at public auction to the highest
7 bidder for cash in lawful money of the United States at the minimum bid set in accordance with California
8 Revenue and Taxation Code Sections 3698.5(a) and 3698.5(c) as specified below:

9 1. **Group 1** consisting of seventy-two (72) prime season timeshare intervals, or less,
10 will be offered for the first time at a minimum bid of the full redemption amount plus \$540.00 per interval
11 for the cost of sale,

12 2. **Group 2** consisting of thirty-one (31) high season timeshare intervals, or less, will
13 be offered for the first time at a minimum bid of the full redemption amount plus \$540.00 per interval for
14 the cost of sale,

15 3. **Group 3** consisting of seventy-four (74) high season timeshare intervals, or less,
16 will be offered for the first time at a minimum bid of the full redemption amount plus \$540.00 per interval
17 for the cost of sale,

18 4. Any timeshare interval in **Group 1**, consisting of seventy-two (72) prime season
19 timeshare intervals, or less, that does not sell at the full redemption amount plus cost, will be reoffered at
20 a minimum bid of \$1,000.00 each which includes the cost of sale,

21 5. Any timeshare interval in **Group 2** consisting of thirty-one (31) high season
22 timeshare intervals, or less, that does not sell at the full redemption amount plus cost, will be reoffered at
23 a minimum bid of \$750.00 each which includes the cost of sale,

24 6. Any timeshare interval in **Group 3** consisting of seventy-four (74) high season
25 timeshare intervals, or less, that does not sell at the full redemption amount plus cost, will be reoffered at
26 a minimum bid of \$540.00 each which is the cost of sale.
