SUBJECT: Approval of Sheriff's Schedule of Fees for FY 2007-08 and the Introduction of Amended Ordinance Nos. 608, 791, 836 and 837

RECOMMENDED MOTION: Move that the Board of Supervisors:

 Ordinance No. 837.2 (An Amendment to an Ordinance of the County of Riverside authorizing the Sheriff-Coroner-Public Administrator to charge a fee of \$2,153 for the performance of an autopsy).

The Sheriff's Department has computed the appropriate billing rates for the Sheriff's Schedule of Fees for FY 2007-08, in accordance with the associated legal authority. These rates reflect full cost recovery for all services listed. The only rates that have not appeared previously on the Sheriff's Schedule are those for providing photos to the public on DVD.

The Schedule includes four fees that require modification and are established by County Ordinance. Specifically, these Ordinances are:

Ordinance No. 608, last amended by the Board on October 31, 2006, established a fee of \$241 for the removal and storage of a body. Based on FY 2005-06 expenditures and current average salaries and benefits for positions involved in the process, Sheriff's staff proposes the fee be set at \$216 in FY 2007-08.

Ordinance No. 791, last amended by the Board on June 6, 2006, established a fee schedule for the testing and training involved for the Sheriff's Department to issue a two-year permit to carry a concealed weapon. Based on current average salaries and benefits for training personnel, Sheriff's staff proposes that the training fee for initial and renewal permits be decreased from \$111 to \$100. In addition, the Schedule also details costs for the three-year Judicial permit and the four-year law enforcement Reserve Officer permit.

Ordinance No. 836, last amended by the Board on June 6, 2006, established a fee of \$55 per month per County Correctional Facility for bail bond signboard advertising. Staff has recalculated the fee for FY 2007-08 and proposes a monthly fee per facility signboard of \$54.

Ordinance No. 837, last amended by the Board on June 6, 2006, established a fee of \$2,279 for the County Coroner's Office to conduct an autopsy. Based on FY 2005-06 expenditures and current average salaries and benefits for positions involved in the process, Sheriff's staff proposes the fee be set at \$2,153 in FY 2007-08. If Toxicology and Histology tests are required, charges from a contracted laboratory will be added to this fee.

As indicated above, Sheriff's staff is proposing that public hearings on the modification of the fees associated with these Ordinances be set for July 17, 2007.

3 **AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF**
4 **RIVERSIDE, STATE OF CALIFORNIA, AMENDING ORDINANCE NO. 608**
5 **RELATING TO REMOVAL AND STORAGE FEES CHARGED BY THE CORONER**

6 The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

7 Section 1. Section 1 of Ordinance No. 608 is amended to read as follows:

8 "Section 1. Pursuant to Government Code Section 27472, whenever the Sheriff-
9 Coroner-Public Administrator takes custody of a dead body pursuant to law, he or she
10 may charge and collect from the person entitled to control the disposition of the remains,
11 as specified in Section 7100 of the Health and Safety Code, the actual expense incurred
12 by the Coroner in removing the body from the place of death and keeping the body until
13 its release to the person responsible for its internment. The charge under Government
14 Code Section 27472 shall not exceed one hundred dollars (\$100.00);

15 "Government Code Section 54985 (a) provides that notwithstanding any other
16 provision of the law that prescribes an amount or otherwise limits the amount of a fee or
17 charge that may be levied by a County, a County Board of Supervisors shall have the
18 authority to increase or decrease the fee or charge, that is otherwise authorized to be
19 levied by another provision of law, in the amount reasonably necessary to recover the
20 cost of providing any product or service or the cost of enforcing any regulation for which
21 the fee or charge is levied. The fee or charge may reflect the average cost of providing
22 any product or service or enforcing any regulation. Indirect costs that may be reflected
23 shall be limited to those items included in the federal Office of Management and Budget
24 Circular A-87 on January 1, 1984;

25 "The Sheriff-Coroner-Public Administrator has calculated the amount of \$216.00, as
the average cost incurred when removing a body from the place of death and keeping the

1 body until its release to the person responsible for its internment. This fee shall include
2 the following: salaries and benefits of County employees, indirect expenses and expenses
3 for materials and services; and

4 "The Sheriff-Coroner-Public Administrator is authorized to charge and collect from
5 the person entitled to control the disposition of remains, as specified in the Health and
6 Safety Code Section 7100, the fee of \$216.00 when removing a body from the place of
7 death and keeping the body until its release to the person responsible for its internment."

8 Section 2. This Ordinance shall take effect 30 days after the date of adoption.

7 The Board of Supervisors of the County of Riverside, State of California, Ordains as follows:

8 Section 1. Section 1 of Ordinance No. 791 is amended to read as follows:

9 **“Section 1.** The Board of Supervisors establishes the following schedule of fees
10 for the issuance of a concealed weapon permit by the Sheriff of the County of Riverside:

Fee for Issuance of New Permit (In addition to training fee)	\$100.00
Initial and Annual Firearms Eligibility Checks	\$ 22.00
Fee for Issuance of Renewal Permit (In addition to training fee)	\$ 25.00
Fee to Modify a Permit	\$ 10.00
Psychological Testing	See Section 2.”
