BACKGROUND: By Minute Order 3.16 of October 31, 2006, the Board entered into an agreement with Palomar Grading and Paving, INC. of Escondido, CA for the Reconstruction of Segments of Tenaja Road and Clinton Keith Road in the Santa Rosa Plateau / Murrieta area of Riverside County. The authorized amount of the contract was \$491,880.00. The total amended contract amount (including quantity adjustments) is \$522,637.14, which is 6.3% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on March 23, 2007. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4505120107 & 4505120108 .
