**SUBJECT:** Ratify Amendment 01 of the Agreement with the State of California Department of Health Services and Community Health Agency, Department of Public Health for Women, Infants and Children (WIC) Supplemental Nutrition Program (#05-45785 A01).

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify Amendment 01 of the Agreement with the State of California Department of Health Services and Community Health Agency, Department of Public Health for Women, Infants and Children (WIC) Supplemental Nutrition Program (#05-45785 A01) effective October 1, 2006 through September 30, 2008, in the amount of \$1,357,580; and
- 2) Authorize the Chairperson to sign six (6) originals of said Agreement on behalf of the County.

**BACKGROUND:** This amendment reflects an increase in funding resulting from a change in the WIC Funding Formula due to an increase in available program funding. The WIC program offers nutrition education, counseling, vouchers for the purchase of nutritious food, and referral to health care and other resources needed by the women, infants and children served. WIC brings high-risk individuals into the health care system for preventive health.

**FINANCIAL DATA:** The State Department of Health Services maximum annual funding allocation under this Agreement is increased to \$10,375,790. Current authorization to spend funding is \$9,499,918 serving a monthly caseload of 71,150 for Federal Fiscal Year 06/07. As State WIC releases available funding, a "Local Agency Contract Authority to Spend" letter will be received by the Community Health Agency. Budget adjustments for the release of funds will be made by CHA Fiscal during quarterly adjustment periods as necessary.
