**SUBJECT:** Heritage High School Scoreboards and Marquee in Romoland

**RECOMMENDED MOTION:** That the Board of Directors:

1. Make the following findings:
  - a) The proposed Heritage High School Scoreboard and Marquee Project is of benefit to the Homeland and Romoland Redevelopment Project Areas and will help to effectuate the purposes of the Redevelopment Plan for the Project Areas;
  - b) No other reasonable means of financing the project is available to the community due to limited school funds which are insufficient to provide new facilities;
  - c) The proposed project will assist with the elimination of blighting conditions within the Project Areas by providing improved school and recreational facilities; and,
  - d) School facilities and recreational facilities are identified as eligible projects in the Implementation Plans for the Project Areas.
2. Approve the attached agreement between the Perris Union High School District (PUHSD) and the Redevelopment Agency for the County of Riverside (the "Agency") to provide \$138,000 for the purchase and installation of three scoreboards and a marquee at the new Heritage High School; and
3. Authorize the Chairman to execute the agreement on behalf of the Board.

**BACKGROUND:** It is proposed that Agency provide \$138,000 to PUHSD for the procurement and installation of four digital scoreboards at facilities at the new Heritage High School on Briggs Road in Romoland. PUHSD recently issued \$46,000,000 in bond proceeds to fund schools throughout the district, however, the funding is not enough to complete the facility. The Agency funding of \$138,000 will allow PUHSD to procure and install 3 state of the art digital scoreboards and a marquee for use at facilities at the new Heritage High School.

Agency staff recommend approval of the attached agreement between the Agency and PUHSD for the procurement and installation of the scoreboards and marquee at the new Heritage High School. The agreement has been approved as to form by Agency Counsel.
