
**RECOMMENDED MOTION:** That the Board of Supervisors:

**BACKGROUND:** In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 16, 2004 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 20, 2004. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 9, 2004, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1) Claim from Nationwide Asset Recovery Service, agent for Steven Frederick based on an Authorization for Agent to Collect Excess Proceeds dated May 10, 2004, based on an Order Settling Final Account of Administrator and Decree of Distribution recorded September 27, 1977 as Instrument No. 190366.
- 2) Claim from Nationwide Asset Recovery Service, agent for Mary R. Frederick-Estrada based on an Authorization for Agent to Collect Excess Proceeds dated May 7, 2004, based on an Order Settling Final Account of Administrator and Decree of Distribution recorded September 27, 1977 as Instrument No. 190366

Pursuant to Section 4675 (a) & (c) of the California Revenue and Taxation Code, it is the recommendation of this office that Nationwide Asset Recovery Service, agent for Steven Frederick be awarded excess proceeds in the amount of \$1,962.99 and Nationwide Asset Recovery Service, agent for Mary R. Frederick-Estrada be awarded excess proceeds in the amount of \$1,962.99. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.
