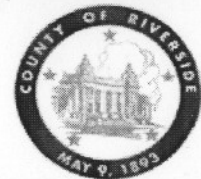

**SUBJECT:** Final Intent to Participate and Addendum to Memorandum of Understanding with the California Department of Justice (DOJ) for the Electronic Recording Delivery System.

**RECOMMENDED MOTION:** That the Board of Supervisors:

Approve and sign the Addendum to Memorandum of Understanding with the California Department of Justice for the Electronic Recording Delivery System, effective for the period July 1, 2007 through June 30, 2008.

**BACKGROUND:** On May 16, 2006, Agenda Item Number 3.2, Participation with the California Department of Justice (DOJ) to set standards for electronic recordation, was approved by the Riverside County Board of Supervisors. The Electronic Recording Delivery System (ERDS) project allows for counties to electronically record real-property transactions. ERDS will increase the overall efficiency and security of the recordation process. The DOJ, and 21 other counties, are participating on this project. Riverside County's cost to participate for FY 2007-08 is \$48,554.49.
