3 RESOLUTION OF THE BOARD OF SUPERVISORS REMOVING AND ADDING APPLICANT
4 AGENTS FOR THE PURPOSE OF SECURING FEDERAL AND STATE FINANCIAL
5 ASSISTANCE FOR DISASTERS AND OTHER EMERGENCIES

6 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of
7 Riverside, State of California, in regular session on August 28, 2007, that Robert Byrd, by virtue
8 of his position as the County Auditor / Controller having responsibility for financial recovery
9 following a disaster is hereby added to the County of Riverside list of applicant agents, that is,
10 those authorized to execute for and on behalf of the County of Riverside, applications and
11 documents as may be required by and filed with the State Office of Emergency Services for the
12 purpose of obtaining financial assistance under Public Law 93-288 as amended by the Robert T.
13 Stafford Disaster Relief and Emergency Assistance Act of 1988, or state financial assistance
14 under the National Disaster Assistance Act. Gail Barclay is hereby removed from the list because
15 she no longer holds a position that qualifies her as applicant agent. Larry Parrish, County
16 Executive Officer, John Hawkins, County Fire Chief, and Mary Moreland, Deputy Director,
17 County Fire / OES, shall remain on the list of authorized applicant agents.
