SUBJECT: Approval of the Agreement between the County of Riverside and the California Perinatal Quality Care Collaborative (CPQCC)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Membership agreement with the CPQCC, effective January 1, 2006; and
- 2) Authorize the Chairperson to execute three (3) copies of the Agreement; and
- 3) Direct the Clerk of the Board to return all three (3) copies of the signed originals to Riverside County Regional Medical Center (RCMRC) administration. Upon final execution by CPQCC, a fully executed agreement will be return to the Clerk of the Board.

BACKGROUND: On July 26, 2005 agenda no. 3.49 an agreement was approved between the County of Riverside and the CPQCC for the reporting of hospital-level performance data of services provided in the Hospital's Perinatal and Neonatal Intensive Care Units that is a requirement of participation for the California Children's Services (CCS) Program. This new agreement establishes the period of performance for the agreement effective January 1, 2006 for a period of three (3) years with automatic renewal on an annual basis.

This Agreement has been approved as to form by Riverside County Counsel.
