SUBJECT: Approval of the Mental Health Services Agreement between the County of Riverside and Kaiser Foundation Hospitals (KFH)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Hospital Services Agreement, dated June 1, 2007;
- 2) Authorize the Chair person to sign three (3) copies of the Agreement; and
- 3) Direct the Clerk of the Board to return all three (3) copies of the signed originals to RCRMC Administration. Upon final approval by KFH, a fully executed agreement will be returned to the Clerk of the Board.
- 4) Direct the Clerk of the Board to hold this Agreement as a confidential document, not subject to release under the Public Records Act, and Health and Safety Code Section, 1457 (C) (1).

BACKGROUND: On January 15, 1991, agenda item no. 3.45, the Board of Supervisors approved an agreement with KFH. The agreement was first amended August 12, 1997, agenda no. 3.45 revising the rates paid for hospital services. This agreement increases the per diem rate paid for inpatient adult and adolescent mental health inpatient services along with removing payment for the professional services from the agreement.

BACKGROUND (Continued):

A separate agreement between the Department of Mental Health and KFH will provide for payment of professional fees. This Agreement is applicable to KFH members only. The rates charged to KFH allow for the recovery of costs for the services provided.

FINANCIAL STATEMENT:

The total financial payment is dependent on the number of Kaiser enrollees referred to the hospital for inpatient and outpatient services.

The Agreement has been approved as to form by Riverside County Counsel.
