**SUBJECT:** Fiscal Years 2006-2007 and Fiscal Year 2007-2008 Medical Services Agreements with Contract Clinics for the Medically Indigent Services Program (MISP)

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Medical Services Agreements for the County Network Clinics for the period of July 1, 2006, through June 30, 2008;
- 2) Authorize the Chairperson to sign three (3) copies of each Agreement; and
- 3) Direct the Clerk of the Board to retain one (1) original of each Agreement and return two (2) fully executed originals of each Agreement to Riverside County Regional Medical Center, Administration.

**BACKGROUND:** The Contract Clinics provide necessary medical treatment services to MISP eligible patients. The fiscal year 2006-2007 and 2007-2008 Agreements are equivalent to previous annual contracts. Maximum annual compensation per agreement is noted on Page 2.

The Agreements have been approved as to form by County Counsel.

**BACKGROUND (Continued):**

Maximum Annual Compensation, per Agreement:

Desert AIDS Project .....	\$120,000
Neighborhood Healthcare (Temecula) .....	\$45,000
Las Clinicas de Salude del Pueblo, Inc./Blythe Family Health Clinic.....	\$55,000
Mecca Health Center.....	\$55,000
Riverside/San Bernardino Indian Health Clinic.....	\$5,000
Indio Emergency Medical Group (Santa Rosa).....	\$55,000

MISP pays medical claims to the clinics under approval of a previous Form 11 approved under Agenda Item Number 3.64, dated 8/10/2004 which authorizes MISP to pay medical services without securing competitive bids in accordance with Ordinance 4594.

These agreements secure a price per visit and set the maximum annual compensation per fiscal year.
