SUBJECT: Change the Name of a portion of Newport Road to Normandy Road, in the Menifee area, Third Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2007-035, Change the Name of a portion of Newport Road to Normandy Road.

BACKGROUND: This change is at the request of Audie Murphy Ranch LLC. It is due to the realignment of Newport Road and the development of Tract Map 31393 and Tract Map 31391. This realignment and development is consistent with the current General Plan. The Historical Commission has reviewed the proposed street name change and has no objections. The adjacent property owners have been notified of the proposed name change. The Transportation Department sent five (5) letters of which three (3) responded in favor of the name change, one (1) responded in opposition, and one (1) property owner did not respond.

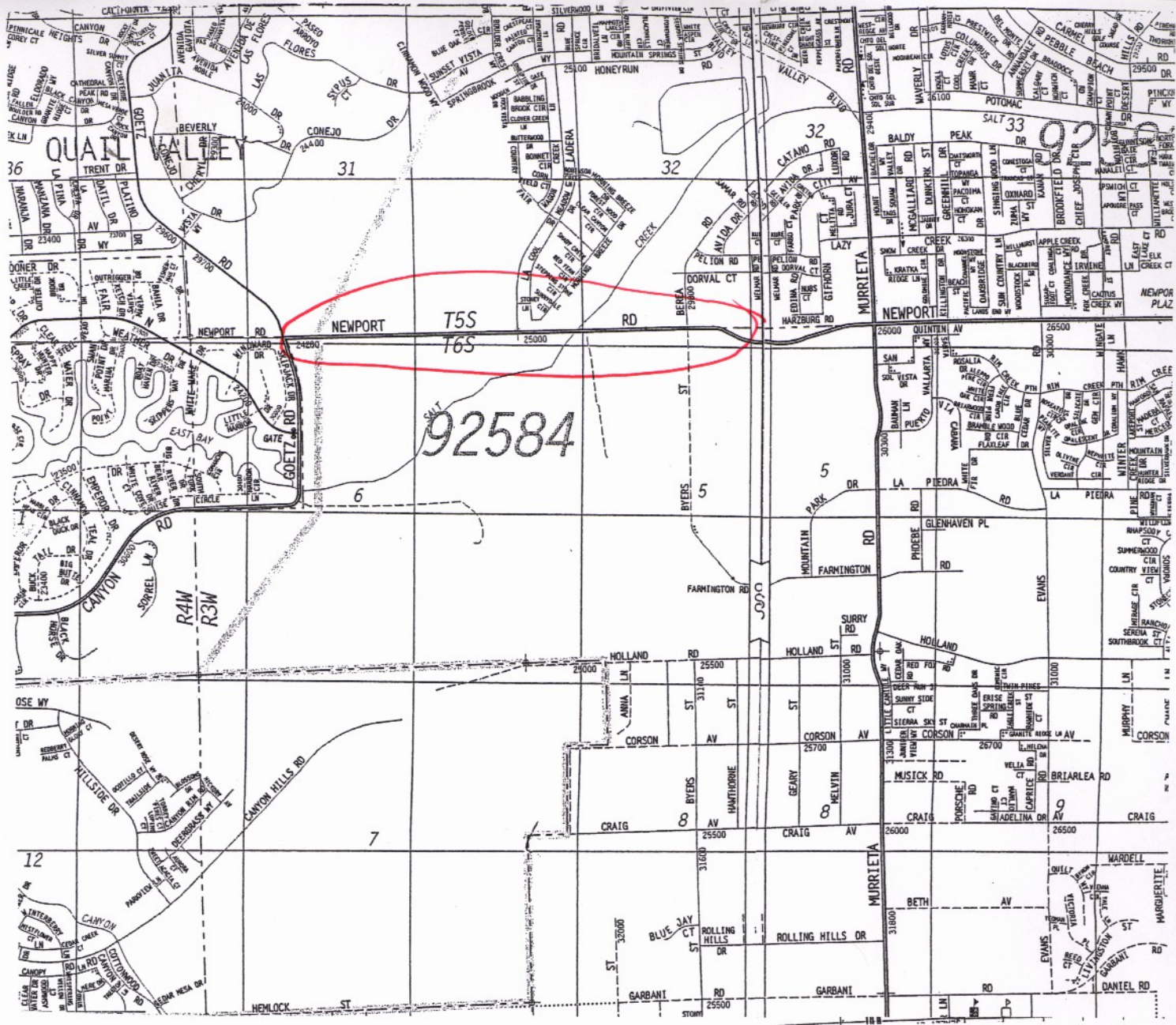
