SUBJECT: Approval of Grant Application to the California Office of Emergency Services (OES) for Continuation of the Violence Against Women Program (VAW)

RECOMMENDED MOTION: Move that the Board of Supervisors authorize:

- 1) The Chief Probation Officer to submit the attached Violence Against Women Program Grant Application and to execute the grant agreement on behalf of the County;
- 2) The Chair of the Board of Supervisors to sign the Certification of Assurance of Compliance within the Grant Application.

BACKGROUND: On April 1, 1999, the Probation Department began operation of a specialized domestic violence unit under a federally funded grant administered by OES. Adult offenders of violent crimes against women in the Riverside-Moreno Valley area are supervised by staff in the Adult Division of the Probation Department. The program provides intensive supervision of no more than 40 cases per probation officer and involves at least one weekly unannounced face-to-face contact with the offender, primarily in the field.

The grant has been extended annually, and OES has made \$124,969 of the federal funds available to continue the program from October 1, 2007 through September 30, 2008. The annual program cost of \$166,625, includes a required match of \$41,656 which is budgeted for the current fiscal year. This will fund one Deputy Probation Officer and one Senior Probation Officer position. The attached application has been approved as to form by the Office of County Counsel.
