**SUBJECT:** Professional Medical Services Agreement between the County of Riverside and Loma Linda University Health Care, Department of Otolaryngology

**BACKGROUND:** On July 16, 2002, Agenda No. 3.17, an agreement was approved with the Loma Linda University Surgery Medical Group, Inc., Division of Otolaryngology, Head and Neck Surgery, for the provision of Otolaryngology, Head and Neck Surgery professional services to the patients at RCRMC on an inpatient, outpatient and emergency basis. The Loma Linda University Surgery Medical Group, Inc., now known as Loma Linda University Healthcare has provided professional Otolaryngology, Head and Neck Surgery, professional services to the hospital for over ten (10) years.
