**SUBJECT:** Change the Names of Center Street to Old Highgrove Road and Spring Street to Blue Mountain Drive in the Highgrove area, Fifth Supervisorial District.

**RECOMMENDED MOTION:** Adopt Resolution No. 2007-227, Change the Names of Center Street to Old Highgrove Road and Spring Street to Blue Mountain Drive.

**BACKGROUND:** This change is at the request of SMR Ventures, the applicant for Tract Map 29598 and Tract Map 29597 and the Riverside County TLMA GIS Division. It is necessary to avoid address duplication within the development east of Mt. Vernon Avenue. The Historical Commission has reviewed the proposed street name change and has no objection. The adjacent property owners have been notified of the proposed name change. The Transportation Department sent fifteen (15) letters of which one (1) responded in favor of the name change, two (2) responded in opposition and twelve (12) property owners did not respond.

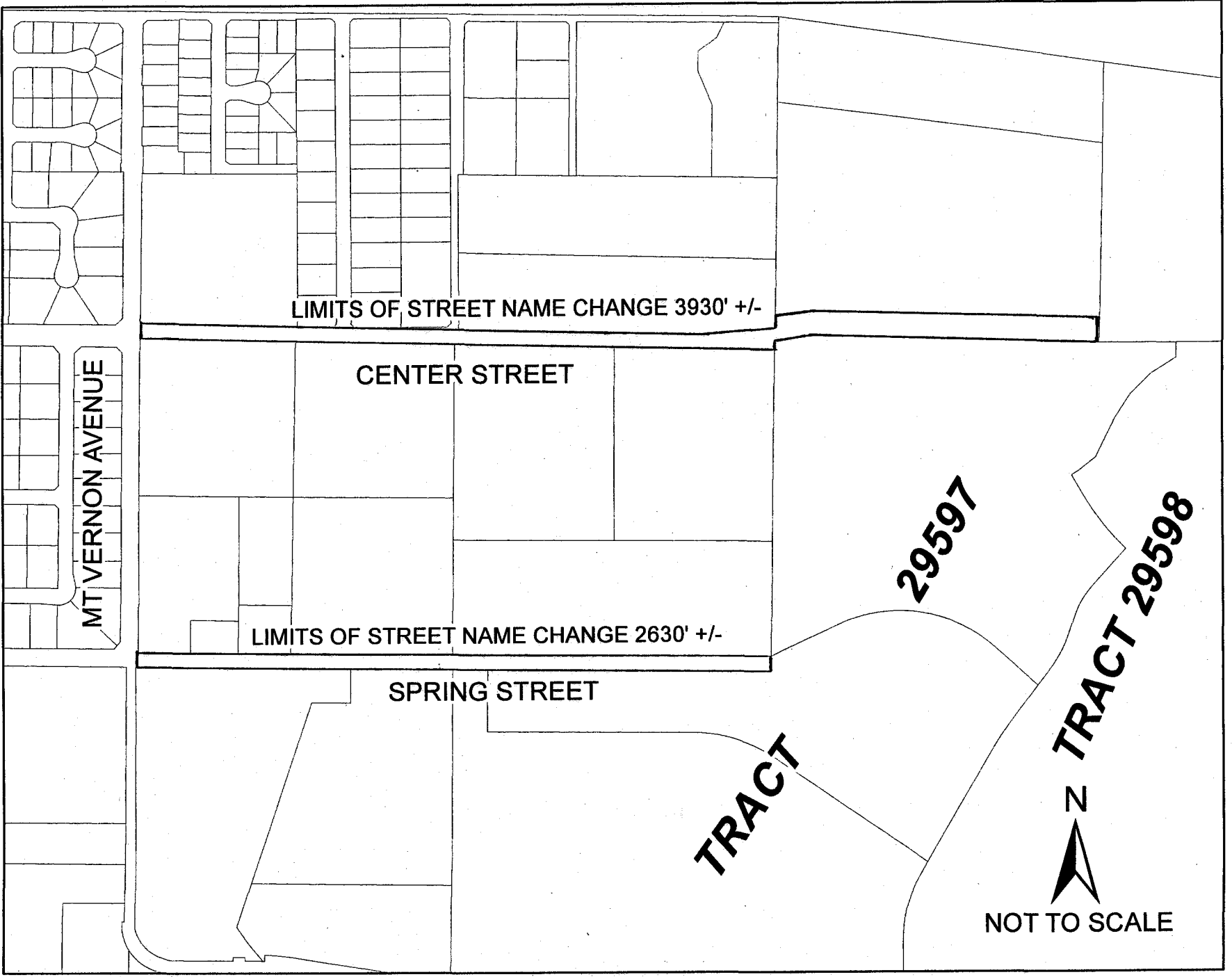

LIMITS OF STREET NAME CHANGE 2630' +/-

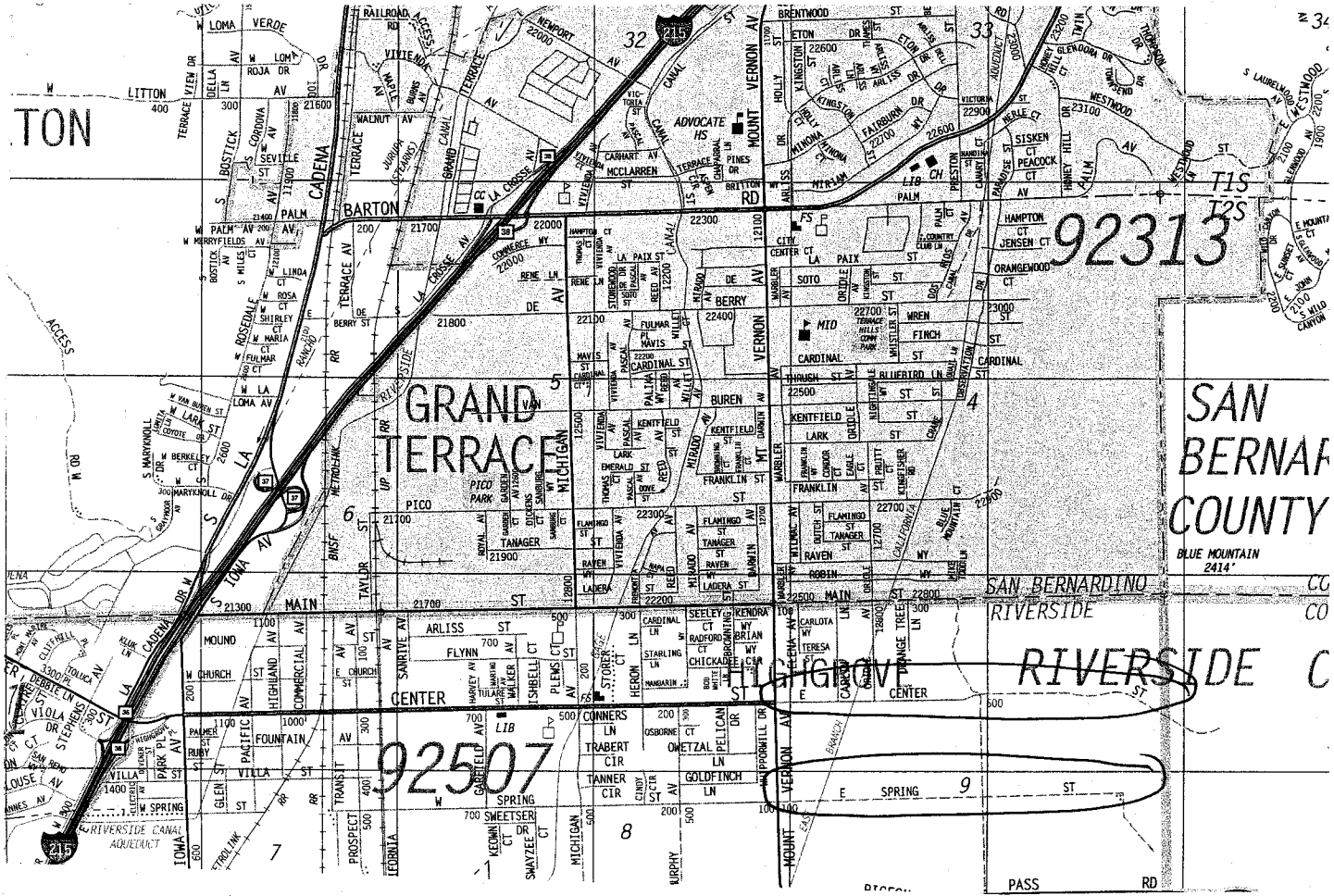
