**BACKGROUND:** cont'd

The Department of Mental Health's Inpatient Quality Improvement and Patient's Rights Office have conducted a review of the facilities listed on Attachment A and have found the program to be in compliance with the criteria for designation. We are, therefore, requesting that the Board designate the facilities for involuntary detention of mentally disordered persons for evaluation and treatment.

The County of Riverside has only three designated facilities (Moreno Valley Community Hospital, Oasis and RCRMC) within the county, which necessitates the need to designate additional facilities in bordering counties to meet the needs of the residents of Riverside County.
