SUBJECT: Approval of Contract HU 0910-00 & HU 3262-00 between the Riverside County Department of Public Social Services (DPSS) and the Housing Authority for the Shelter Plus Care Program

RECOMMENDED MOTION: That the Board of Commissioners:

1. Approve the attached Contract HU 0910-00 in the amount of \$133,584 for the period June 17, 2007 through June 16, 2008 and Contract HU 3262-00 in the amount of \$320,508 for the period September 4, 2007 through September 3, 2008; between the Department of Public Social Services (DPSS) and the Housing Authority to provide tenant-based rental assistance for mentally-ill, chronically homeless persons in the eastern and western area of the County; and
2. Authorize the Assistant County Executive Officer/EDA or designee to execute the contract and to take the necessary steps to implement the contract, including execution of necessary and related documents.

BACKGROUND: The County has entered into a grant agreement with the U.S. Department of Housing and Urban Development (HUD) to provide housing assistance and supportive services for mentally-ill, chronically homeless persons.
