Pursuant to Elections Code § 10515, the Board of Supervisors shall appoint any person so nominated prior to the Monday before the first Friday in December. If no person has filed a declaration of candidacy for any office, the supervising authority shall appoint any person to the office who is qualified on the date when the election would have been held.


